CONGRESSIONAL.

SENATE.

Withdrawal of Currency—Health

Washington, D. C., Feb. 3.—Sherman, from

the finance committee, reported a bill

providing for the withdrawal of

twenty-five millions in currency

from the states which have an ex-

cess of their rightful proportion,

and the re-distribution of the same

in the Western and Southern States

which are short of their just pro-

portion; he gave notice that he

would call it up at an early day for

action, and said that it was approved

by the Secretary of the Treasury

Comptroller of the Currency, and

the entire finance committee. It

was placed on the calendar.

Sargent introduced a bill for the

establishment of a health bureau,

to be under the charge of the Interior

Department; referred to the

committee on Labor and Labor

The Senate then proceeded to the

consideration of the bankruptcy

bill, and Edmunds explained the

amendments thereto, heretofore

published.

HOUSE.

Army Appropriation Bill.

The House went into committee

of the whole on the army appro-

priation bill. Garfield said the

amendment he offered restricted

the army to 25,000 men. He in-

dicated as places whence troops could

be removed the harbor of New

York, where there are twelve hun-

dred, and the Canadian border,

where there are not a British soldier

on the line from the mouth of the

St. Lawrence to Pem-

bina.

Wheeler moved to add to the bill

a proviso that no money appropri-

ated by the army beyond 25,000 en-

listed men; agreed to.

Thomas, from the election com-

mittee, reported a resolution that

Hodges, of Arkansas, had a *prima*

facie right to a seat.

EASTERN.

Big Fire, 500 Men Thrown Out

of Work.

MEMPHIS, Tenn., 3.—The ma-

chine shops of the Memphis and

Louisville railroad, in the northern

suburbs of this city, were burned

to-night, with all the machinery,

five locomotives and seven cars;

loss \$150,000, no insurance. Five

hundred men are thrown out of

employment.

Loss by Fire.

PROVIDENCE, R. I.—A fire at Allen's

print works to-night destroyed the

calendering and steam dyeing

buildings; loss seventy to a hun-

dred; insurance, \$100,000.

The loss on the mill and machin-

ery at Millville, Mass., this morn-

ing was \$22,000, insured \$17,000.

The Health Bureau—Serious

WASHINGTON, 3.—Sargent's bill

for a health bureau proposes to es-

tablish, at open account, the books of
