CAMPBELL will not stop the ravages of moths in carpets after they commence eating. They pay no heed to the presence of camphor, cedar or tobacco. A good way to conquer them is to take a can of kerosene and stir it in clean water. Spread it smoothly on the carpet, then iron it dry with a good hot iron, repeating the operation on suspected places, and on those last used. It does not injure the color of the pile of the carpet in the least, as it is not necessary to press hard, heat and steam being the agents, and they do the work effectually on worms and eggs. Then the camphor will doubtless prevent the future depredations of the miller.
