Cheyenne, Wyo., May 9 .- The charred remains of two more victims of the Union Pacific accident at O'Neill sidetrack were found in the wreckuge to-day. Both bodies were so badly burned as to render identification impossible. One of the bodies was that of a boy, Papers in the pockets of one of the un-known victims found yesterday indi-cate that his name was Daniel Shay. and that he had recently been employed at Rock Springs. FRUIT TREES ALONG THE ROAD-SIDE.

In Europe where land is more valuable than in America, fruit trees often line the highways throughout large States it has occurred to but few to plant fruit trees by the roadsides in this country, and yet why should they not do se? If the roadsides in this country were carefully and properly planted to desirable varieties of truit, properly pruned, sprayed, mulched and attended to, the revenue would amount to hundreds of thousands of dollars, and yet it would not cost one cent so

far as the value of the land goes upon which these trees are planted. Here is an opportunity for making money that should be visible to all, and which should be made the most of. Recently, says the editor of Green's

Fruit Grower, as I was driving through the country, my altention was called t a long row of apple trees on one side of the highway. It was not possible to plant trees on the opposite side of the road, since a bank of the river ran close to the wagon track. These trees were heavily laden with beautiful specimens of fruit. Here was revenue to the owner, of perhaps, a thousand dolrs, with scarcely any expense except of gathering the fruit;

I often recall a mile or more of cherry trees planted by an old neighbor of nine along the roadside that bordered its farm. These cherty trees hore avy crops of fruit every year, which even at the low prices of recent years. ould yield a revenue of several thou sand dollars. Apple. plum, pear and cherry trees seem the most desirable

for readside planting, Many people are deterred from planting fruit trees along the planting fruit trees along the coadside from fear that the fruit wil e stolen, or molested by travelers. My xperience teaches that there is but lit-le trouble from this source. In the arge planting along the roadside in Surope we hear of no such complaint Both summer and fail apples are gath-ered and marketed before they are ripe enough to be eaten from the hand; plums and pears are also marketed before they are catable. But in addition to this, where there are several hundred fruit trees along the roadside there is such an abundance of fruit no one would miss a few hundfuls eaten by the passers-by. But the fact is that tray-elers respect the confidence placed in them by the planting of fruit trees along the roadside, and do not molest the fruit.

How greatly would the beauty of the country be increased were the planting of fruit irees prevalent along the road-side. When in blossom or in fruit they could add to the pleasure of the travelers who drive along these roads. Is it not surprising that the American peo-should have overlooked the planting of the roadside fruit trees?
