

TELEGRAPHIC. EXPLOSION OF GAS.

Light Was Burned to a Crisp in a Pennsylvania Coal Mine.

Others Will Probably Die. Particles of the Disaster as Told by One of the Escaped Miners.

WILKESBORO, Pa., Oct. 7.—Shortly after 1 o'clock this afternoon a terrible explosion of gas occurred in the Durbin mine, operated by the Lehigh Valley Coal company, which is situated in the northern part of this city. It is estimated that more than 100 men were in the mine at the time. The explosion was so violent that it is almost impossible to get any accurate description from the survivors. At 5 o'clock five men were seen, but they were all badly injured, and their condition is very serious.

Death of a Soldier. On the 5th of November the death of a soldier was announced. The soldier was killed in the line of duty while serving in the United States Army.

Attacked by a Snake. A man was attacked by a snake while working in a field. The snake was a rattlesnake and the man was badly injured. He was taken to the hospital and is now recovering.
