Timpson, at 153 North Fourth West street; Herbert Heeding, aged 9, and Minnie Heeding, aged 6, at 347 East Second South street. It was reported to the state board of health yesterday that one Orrin Rose, aged 33, who lived at Parowan, died at that place on the 15th inst. of confluent

smallpox. The communication also stated that 111 cases of the disease had developed at Parowan since the epidemic had broken out there, four new cases coming to light yesterday.

The board was likewise notified of five new cases at Bountiful, three in Payson, one in Davis county outside of Bountiful, and one at St. George, which, it is stated, is the first instance of the disease breaking out in the capital of Dixie.

RACE WAR IS ENDED.

Tom Williams Secures Control of Ingleside and Tanforan Tracks.

San Francisco, March 18 .- At a conference of race track managers held at an early hour this morning Tom Williams, president of the California Jockey club, secured control of the In-bleside and Tanforan tracks. This gives him control of the three tracks. Ingleside will remain idle owing to the veto of the mayor, but the Tanforan and Emeryville tracks will run in alternation after today, each track to race for thirty days. There will be racing at both Emeryville and Tanforan today. It is said that the consideration in the deal was \$600,000.

The announcement of this big trans-

fer of racing interests came as a surprise to sporting men. It is said that the San Francisco Jockey club will maintain its organization, but its plans for the future have not been revealed. The details of the agreement between the recent racing track rivals are known only to those directly interested, but it is understood that satisfactory arrangemens for a continuance of the sport have been made. There is considerable conjecture among horsemen as to the effect of the consolidation of tracks upon suspended riders who have recently been recognized b- the San Francisco Jockey club. In this connection the statement of President Williams of the California Jockey club that he will treat all horsemen and jockeys as well as he possibly can is accepted as an intimation that his club is prepared to extend to them all the privileges possible. The Emeryville track will be closed tomorrow to altrack will be closed tomorrow to allow the Tanforan people to complete their season of thirty days, after which the new agreement will be finally ratified. It is stated that the purchase price of the Tanforan and Ingleside tracks is to be paid in three annual installments of \$200,000 each. Prince Pontatowski press of the Car Vergeles. latowski, president of the San Francisco Jockey club, says that President Wil-liams of the opposing organization has thirty days in which to complete his part of the bargain, but he does not doubt its consummation.
