CONGRESSIONAL.

SENATE.

WASHINGTON.—Cole introduced a bill providing that, after June 30, 1873, it shall be lawful to receive twenty per cent. of custom dues in United States notes, and a twenty per cent. additional proportion each year thereafter, until 1877, when the duties may be paid either in gold or United States notes. At the expiration of the morning hour, the senate proceeded to the consideration of a bill on the calendar. On motion of Stewart, a bill to define the rights of miners, and encourage the development of mines, was indefinitely postponed. Sumner's joint resolution, proposing an amendment to the constitution, containing the French spoliation bill, was referred to the Judiciary committee. The French spoliation bill was postponed till Monday next.

HOUSE.

Gallegas introduced a bill for the construction of a military road in New Mexico. Banks introduced a bill to create a commission to award damages to claimants under the Geneva arbitration. Hooper, Mass., introduced a bill appropriating twenty thousand dollars to the fireman's fund of Boston, in reward for the services of the firemen whose exertion saved the safe of the treasury at the recent great fire in Boston. After the reading of the bill was referred to the committee on appropriations. Acker moved to suspend the rules and pass a bill removing all political disabilities and extending general amnesty. Negatively, yeas 102, nays 84, less than the necessary two thirds. The speaker announced as a select committee on the celebration of the centennial of the signing of the Declaration of Independence, Kelly, Pa.; Daves, Mass.; Maynard, Tenn.; Sargent, Cal.; Hawley, Conn.; Hays, N. Y.; Marshall, Ill.; and Hancock, Texas.

CHICAGO, 9.—A Washington special of to-day says it is certain the Vice President Colfax has under consideration an offer from persons holding the controlling interest in the New York Tribune to accept the editorial position on that paper, after the 4th of March next. Many prominent Republicans advise Colfax to accept.

man Peters, general manager of the North German Lloyd's Steamship Co. The Stokes case was not taken up in Oyer and Terminer to-day, as expected. King, the murderer of O'Neil, pleaded not guilty in that court to-day.

A Washington special says the Duc de Nemours, French minister, has information from France, that the present crisis will end peacefully. Thiers will be sustained after making some concessions.

Another special says Secretary Delano calls for Cuba on Thursday next, he will be absent one or two months. It is his intention to fill the vacant office, and at the suggestion of the President, who wishes thorough information as to the condition of the affairs of the Island, and expects to get it through the Secretary.

CINCINNATI, 9.—The scaffold on a building being added to the water works fell this afternoon, killing four unknown persons, and wounding four others.

ST. LOUIS, 9.—The horse disease is assuming a more serious type.

NEW ORLEANS, 9.—The House adopted the following—Resolved, That Henry C. Warmouth, Governor, be and is hereby impeached, for high crimes and misdemeanors in office, committed against the constitution and laws of the State. The Senate then declared Warmouth suspended until such time as the charges can be tried and decided. At the evening session a court of impeachment was formed, and Pinchback was qualified as governor.

WESTERN DISPATCHES.

SAN FRANCISCO, 9.—Henry Beck is on trial in the 10th District Court for the murder of Caroline F. Frenel, Carry Mortimer, wife of the notorious Charles Mortimer, in jail at Sacramento, is an important witness for the defense.

JACKSONVILLE, 9.—Mr. O'Donoghue, Sup't. of Indian Affairs, arrived here from Lake County last night. He reports the arrival in the Indian country of two companies of cavalry from Camp Warner. He says the aggregate force in the field, including some Klamath Indians, about 2000 men, are now being kept too busy by scouting parties to be able to commit any more depredations. He says within a week the campaign will be prosecuted so vigorously that but a short time will elapse before the hostile band of Modocs are taken and the war ended. His terms are unconditional surrender and punishment of the offenders.

LOS ANGELES, 9.—The grand jury is reported, find a bill of indictment against the San Diego World for libel.

A fire yesterday, near the city buildings, in the vicinity of Mully's brickyard, entirely consumed the premises, and a horse was burned in the flames.

LONDON, 9.—A terrific westerly gale throughout England yesterday, prostrated telegraph wires and demolished many buildings in this city. A number of pedestrians were dashed violently to the ground, street lamps were blown down, and many persons injured. Eight ships were blown ashore at Plymouth. The flagship *Narcissus* parted her moorings at Davenport, and the ship *Cambridge* and three small merchantmen came to the harbor and were blown ashore. The crew were rescued.

The telegraph wires in the north of England are not yet repaired. Dispatches from all other stations report great destruction of property. The gale was severe in Wales and Ireland, and accompanied by lightning and rain. Several vessels are ashore in Cork harbor, and the damage there was very great. The *Colleen O'Connell*, a schooner, was blown down while the congregation were at worship, and falling on the roof crushed through into the body of the church. The congregation, panic-stricken, fled from the building, but none were killed. Their escape is regarded as miraculous. The *Lozanna*, from Sunderland, for New York, was driven ashore at Lowestoft; the crew barely escaped. Many houses were destroyed. The chapel of Oriel College, Oxford, was badly damaged. The freight depot of the Great Western railway was entirely demolished.

The harbor of Cardiff is crowded with shipping. Over a hundred sail are lying there wind-bound.

A number of cottages at Bridgewater were blown down in the storm of yesterday.
