Precipitation since the first of the month, 1.51 inch, which is .8 inch above the normal.

### WEATHER CONDITIONS.

The barometer is highest over the north Pacific states, and lake region; and lowest over the southern plateau, upper Missouri valley and extreme northern Texas.

Precipitation occurred over portions of Arizona, Washington, Montana, North Dakota, Minnesota, Illinois, Assiniboina, and Alberta. It was raining this morning at Chicago, Ill., and at Bismarck, North Dakota.

The temperature rose 10 degrees or more over northern Utah, Kansas, Nebraska, South Dakota, and Minnesota, with a corresponding fall over northern Utah, Idaho, Montana, and British Columbia. Slight changes occurred elsewhere.
