## CHAMBER OF COMMERCE MEETING.

The Secretaryship—Utah Permanent Exhibit.—Last Office—Mining News.

It was suggested today that it did not seem to be sufficient information to whom the necessary information in how to value the property to determine city warrants, but that where those parties with the warrants provided by the smaller amounts to pay their men, they were subject to a further tax. On this score there was "screwing" and a desire to know what the source was involved in order that the city was permitted to assess extra charges that were not involved in any legal fee bill known to us.

"Resolved, That the board of directors of the Chamber of Commerce endorse the resolution of the Board of Trade of Hawaian, in behalf of the true courage of sailors, and that emblematic resolutions concerning the same be drawn up and forwarded to him."

## LAND OFFICE.

An appeal has been taken, in the name of William Cattanaw vs Cyrus H. Williams, for the recovery of land which was sold to the latter in the fall of 1859 on July 20th. The case is one in which Daniels filed on the land occupied by the town of Snowville and then sold to the State of Utah, but was not with the State of Utah, but was sold to the town of Snowville, which showed that the land had been settled before the application of Daniels. The latter appeals and argues that there was no agreement in the sale, and that the land is used for the town does not take it out of the pre-emption act. ## THE SUMMER SCHOOL.

The following is the qualifying closing Exercises:

At the Utah Summer school yesterday afternoon of the opening of the question was the first feature of the session. Quiet, relating to arithmetic, and art of teaching were discussed, the time being very profitably spent.

In the physical culture class, the course was conducted until testing the lung capacity, together with a walking exercise. A portion of the time was devoted to exercises in stress of voice, impressions being given to the class in three different degrees of voice control.

Drawing as applied to the teaching and the study of physiology was the subject under consideration by Prof. Angerlo. In the absence of a skeleton to illustrate the bones of the body, the blackboard may be utilized in every efficient manner by a picture of the skeleton of the person of the student, the teacher, the nervous system, digestive apparatus, and the various parts of the body were skillfully drawn on the board by the professor, in great estimation and gusto of the members of the class.

The work in Prof. Andrew's class was a continuation of causes, relative classes being especially under consideration, the class being required to produce evidence in all cases which cause was the negative analysis showing causation. A few words concerning the most successful exercises were submitted by Mr. White, the drawing being under his direction of three weeks.
