

MAY DRAY CHANGE HIS MIND IN TIME?

Man Who Holds World's Record in Pole Vault Rests Content.

SAYS HE WILL NOT GO ABROAD

Olympic Team Hopes Yale Wonder Yields to Patriotism Before Amer. Lea Goes Into World Meet.

New York, June 15.—While hundreds of athletes are bemoaning their loss at not having "made" the Olympic team which will represent America at the London stadium next month for the world's championship one of the first to be picked by the American committee, has said that he will not accept the honor and will not compete. He is W. P. Dray of Yale university, a champion with whom the athletes of the whole world are familiar. In fact, his feats in the pole vault have for more than a year been viewed with wonder. For two years he has held the world's record and the intercollegiate championship.

TWELVE FEET, NINE.

At the intercollegiate meet in 1907, he hurled himself into the air, the unprecedented distance of 12 feet 9 inches, and established a mark that remained untouched until he himself, nearly a year later, added another inch to it. At the Olympic tryouts, he was defeated by Gilbert, one of his classmates and stripped of the record and the honor. Dray, however, was not discouraged. He trained and practiced as hard as ever before, with the result that on Saturday at a meet at Danbury, Conn., he cleared the bar at 12 feet 9 inches. So much higher is this than any vault ever recorded that Dray announced immediately after his vault that he was content to rest on his laurels and allow Gilbert, Nelson, Cooke and the other prominent vaulters to strive for the success of his country.

HAVE HOPES STILL.

While Dray is probably sincere in his desire to refrain from competing, those who know him best say that when the time comes for the American pole vaulters to line up in the London stadium, Dray will be one of the first on the field. His patriotism, they say, will lead him to strive for the success of his country.

With the credit of a victory each, the game today will break the tie and decide which will take the coveted trophy. Saturday in New Haven, when the two clashed, Yale won a signifi cant triumph, knocking two of the best Princeton pitchers out of the box and winning by a score of 2 to 1.

New York, June 15.—Four persons were drowned tonight when an automobile carrying a pleasure party of six became unmanageable, shot at wild speed down Fifty-sixth street, and bounded from an open pier into the North river. The machine turned over in its plunge from the pier, holding the four victims fast in its seats. The dead:

Adeline Berdon, aged 19 years.
Mrs. Rose Coleman, aged 23 years.
John Coleman, aged 25 years.
Virginia Knight, 8 years.

John Baier, the chauffeur was carried into the river with the machine but managed to free himself and swim to safety.

John Notan, one of the party, jumped from the run-away machine as it neared the end of the dock.

After taking his employer home to-night Baier invited his friend to a pleasure ride. With the party he ran the machine down Fifty-sixth street at fair speed, intending to go out on the dock. In some manner the brake failed to work and the machine began to skid. Down on the dock it flew and Notan leaped just in time. The four victims were carried down into the water. The body of Mrs. Coleman was recovered shortly before midnight tonight.

After swimming to the pier Baier went to the relatives of the four drowned persons and notified them of the accident.
