Suspicious Developments at McNamee. Wash.—Two City Committees Arrestd.

A fire originating in the Western Hotel at Eglin, Oregon, early Wednesday morning, destroyed the hotel, the entire contents passing into the flames.

The Larimile County jailor, ineligible to vote at Cheyenne, Wyoming, has migrated from the city and country and from all parts of the state in search of work.
