

YET ANOTHER TODAY

The City Retired Company Files One More Damage Suit.

\$25,000 DEMANDED THIS TIME.

For the Death of Little Johnny Lloyd
—Yardini in the Friederich-
son Case.

No sooner had one jury rendered its verdict in a damage suit against the Salt Lake City Retired Company, in which Justice Martin's son was the victim than another was empaneled to try a second cause of action in the same lines. In the second a child had been seriously injured; in the other a child has been a slight outgrowth and \$25,000 out \$200.

It was late yesterday afternoon when the case of Walter B. Friederichson, a minor, by his guardian ad litem, Oscar Friederichson, was given into the jury's hands. The trial had occupied the whole of the day, and the jurors were instructed to begin in a stated venture this morning. They did so. The amount claimed was \$10,000, and the verdict returned was for \$200,000, and it was rendered by nine-jury.

Counsel for the defense of one objecting to the reception of the new-jury verdict, was too ill to argue the case, and the trial was suspended until applied to by Attorney Hartman in which he proposed a re-verdict. The court adjourned until the next day, and this was done.

The second cause which will now begin concerns as to the negligence of First Mayor and Fire Commissioner, Economy, 1894. The minor, who was about six years old at the time he was injured down by one of the defendant company's cars was also taken into custody by the court, and the trial date of the two cases to be suspended.

THIS DAY WAS SPARED.

Nearly all hour was consumed in the preparation of a jury to try the case of Walter B. Friederichson, a minor, the plaintiff is Jesus B. Lewis, a minor, claimant against the Salt Lake City Retired Company.

In no instance damages in the sum of \$25,000 were demanded by the defendant, J. H. Weller, who alleged he was also in the case because of negligence of the defendant.

The plaintiff is represented by Hartman & Hartman, and with whom are associated Attorneys A. H. Doyle and W. C. Dawson. For the defendants Attorneys Howell & Cuthbert again appear.

The father of the deceased child is a minister and resides near the corner of First South and Fifth West streets, where he is a member of the Methodist church. At that time the boy was about two years old. According to the plaintiff's side of the case, he was sent on the date named to school where across the street from the residence of his teacher, Mrs. Williams, he was in the car of Mr. Weller, who was driving up the hill between the car and the car in front of him, and the car struck him. He was carried a distance of thirty to forty feet through the eye Williams' sufferer for distance—and was admitted to the hospital on the evening of the following day. The bones of one of the legs were entirely crushed, the limb being laid completely open from the knee right up to the body. He was soon buried with his mother, who died the same day, leaving his wife and two sons to care for him. It was claimed that the boy's death was clearly the result of carelessness and negligence on the part of the company in having failed to provide proper brakes and brakes in the car, thus, making it impossible to stop the car.

The defendant never denying the main allegation, and aver that the child's death was occasioned solely by his own negligence that while the car was moving with him, with care and diligence, the boy himself ran in front of it after meeting his death.
