

CRIMINAL TRIALS.

J. W. Neal Found Guilty of Assault and Battery at Provo.

CONTINUANCE OF TWO CASES.

Alleged Burglary at the Hotel Residences. The Trial was Made a Big Head.—Judge Berard's Court.

In the Third district court this morning the case of Anna Hess, charged with adultery, at the trial for the term Charles Judd, the woman's accomplice, has been already tried and sentenced to two months' imprisonment.

The trial of J. W. Neal, on a charge of assault and battery upon the person of Hannah Rose, at Penn, Summit county, on January 2d last, was then proceeded with. Assistant District Attorney Howard presented; Attorney W. T. Snyder defended.

The matter came up on appeal of the defendant, who was convicted by Justice Oberst, Williams of Penn and ordered to pay a fine of \$25.

Attorney Snyder made a brief statement, in the outset, on the part of Neal, claiming that on the date named Miss Rose went up to defendant's house and complained of the conduct of his child in reference to one of her own children. She was very angry and excited and not at all disposed to listen to reason. When Neal wanted to talk with her, she continued the same upon him and he requested her to leave. She remained with him until about half past ten o'clock, upon which Neal took her by the left elbow and marched her toward the gate. It was evident in the mouth that Miss Rose was in the case, and when she was marched away, it was apparently caused by the position taking his arm away from her when she had held of his coat sleeve.

The version given by the complainant was quite different, saying that she was either excited or angry, and she did not use improper language. With a tremulous voice and tears ready to flow, she asserted that the defendant "had her by the left elbow, turned her arm and she was unable to dress herself for several weeks." Her arms lay in the mouth about, during a month, keeping out of her front teeth and preventing her from eating and sleeping. "I caught cold," continued Mrs. Rose, "the blood was streaming in my mouth and I very nearly choked."

When Neal was called in corroborating who testified to having seen finger marks upon the complainant's arm and blood upon her dress and mouth shortly after the alleged assault. One of her teeth had also disappeared.

He was asked if he had any information, and after about twenty minutes' deliberation they returned with a verdict of guilty.

There is some talk of a motion for a new trial.
