A BREEZE IN THE ASSEMBLY

Resolution Introduced by Mrs. Horne Today Causes It.

A WARM DISCUSSION ENSUED.

As to Whether the President of the Senate is Presiding Officer of the Joint Assembly—No Senator Yet.

The joint assembly convened at 12 m. The president of the Senate presiding. The first order of business was the reading of a resolution introduced by Mrs. Horne, of the Utah House, relative to the death of her father, Albert Horne, deceased.

An interesting discussion developed just before the hour was taken, and it appeared to involve something of importance, the whole matter was referred to the committee on resolutions, and that afternoon the committee reported.

A resolution was offered by Mrs. Horne, providing that at the joint assembly today Speaker Horne preside, and that after February 1st, they preside alternately.

Johnson opposed the resolution as one calculated to intensify the existing tension and bitterness. He held that the President of the Senate should regulate the session, and it should be left to his discretion whether he should call upon any other person. "I understand," he said, "that this resolution originated in a cabinet held at the headquarters of one of the candidates for Governor. I am opposed to it, as there are no precedents for such a proceeding."

Shepard said that in regard to precedents there were none. The Legislature of Utah, out of the two houses, there is no particular reason for the more important, why the President of the Senate should preside, more than any other officer of the State.

Representative Robinson said: "As a member of the assembly, I am, as you are, opposed to the consideration of this resolution. In every body there is a sense of propriety. In this case the President of the Senate, in regard to whom the resolution is introduced, is a fair and impartial officer, and his presence at the joint assembly is a matter of course."
