Chicago, Nov. 4.—Jack Johnson returned yesterday from Detroit in a big new blue and cream-colored automobile, which he purchased for \$2,100.

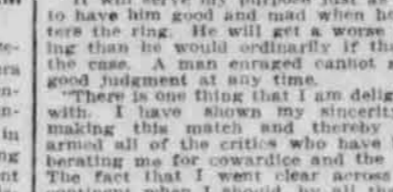
FEW TROUTS FOR JIM JEFFRIES

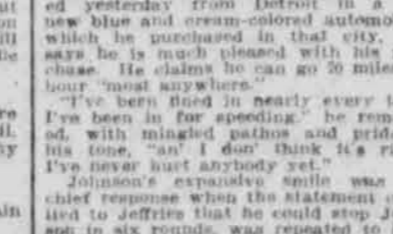
