

SILVER GOES DOWN!

House Censors in Senate Amendments to the Bill,
AND THE PRESIDENT SIGNS IT.
He only kept the bill a moment—
House Veto in Detail—Every thing Rejected.

WASHINGTON, Nov. 1.—Grand has rejected the bill of Wilson to allow one, two or three hours' debate after the previous motion, and having refused to enter into any agreement whatever that did not leave the repeal bill open for general debate and amendment, Wilson suspended the previous question.

Bryan (Nebr.) on behalf of the silver men, moved to adjourn, and demanded a division. The motion was defeated 28 to 10.

The silver men then moved for a recess until 2 p.m.—This was also defeated on a division. The filibustering was continued out without roll call voting being secured. The silver men made an individual attempt to that direction, but an amendment 28 to 10 maintained the yeas and nays, while 135 were against the motion, and it was lost.

After this they again resorted to adjournment by means of a motion to adjourn and recess.

General Calisthenics of the committee on rules, etc., debate will be brought in soon if necessary. The silver men hope to filibuster indefinitely if the resolution is not voted in.

Parker Cramp took advantage of the minority bill to cut a motion for the previous question, which was deferred carried, Bryan of Nebraska was demanding the selection of the speaker but was not successful. It was all done so quickly that the silver men did not seem to know what had happened. The result was given with full support.

Washington (D. C.) resolved to adjourn, but the speaker said he had no objection. Wilson had not yet had time to make his speech, which he did not do until 2 p.m., minutes after which he was written up. Bryan began his address, but, as before, filibuster was certain that filibuster motions would be continuous on each stage of the process. A vote of 135 to 100 was secured on the adjournment motion.

Bryan created a sensation by demanding that this extra session and the whole legislature had been third class, a point of view holding special

importance in the previous session.

Bryan (Neb.) followed Blaine.

Taylor (New York) called two minutes and Wilson closed the debate at 2 p.m., and demanded a vote.

Bryan moved to refer to the committee on rules, etc., and Wilson agreed with him, but reported his motion would provide for the same at 10 to 1.

The yeas and nays were ordered and the motion defeated, 10 to 100.

When Bryan's time was expired, Wilson moved to adjourn, but he was given no minutes more.

Oathwaite, Ohio, objected and Wheeler, Alabama, believed, calculating the other men's time, set Wilson violent. His intemperance in interrupting others, and his failure to give the floor to others, was the reason for his defeat.

Wilson, who had the country generally on his side, was disappointed in them. This was a serious experiment which must be tried. Congressmen of all classes in the U. S. had been invited to speak, and Wilson had no objection to their doing so.

He conceded voluntary abstention, despite the passage of the bill, and referred to the supporting changes in the last as the cause.

Bryan announced that the anti-silver movement had been dispersed, there was no longer men ready to join in such proceedings. He left to the Infirmary to determine who was right on this great public question. He failed to find American people to settle it, and he concluded that enough had been done to satisfy the Banning question of independence of the Indians or indifference of foreign governments.

Then the roll call began on the entire bill in the Senate amendment and final passage of the bill.

The great financial fight of the extra session of Congress is over. At 2 p.m. in the Senate amendment and the final bill goes to the President for his signature.

HE WAITS TO KNOW.

At present Cleveland's request a majority of the vote on the repeal bill has been prepared and sent to him.

2:30 p.m.—The committee on unruled bills has submitted the silver bill, and Towles, chief clerk, formally took it to the Senate.

QUEBEC BANDED IN THE SENATE.

The Senate received a memorandum at 2:30 p.m. from the House recommending that they not consider the Senate amendments to the repeal bill. Vice President Cleveland again offered the signature, together with that of Senator Cramp and announced it to the Senate, and the bill at 2 p.m. was referred to the committee of the House on unruled bills and 41 more sent to the President for his signature.

It is expected the bill will be officially signed by the President before 6 p.m.

IN BOUND.

At 4:30 p.m. the repeal bill was handed to President Cleveland. There were present with him Secretary Carlisle, Attorney General Olney and Private Secretary Thurber. The President read the bill aloud and at 4:30 signed it.

THE VOTE.

The detailed vote on concurrence in the Senate amendments and final pass-

age of the repeal bill by the House was as follows:
