## THE DUNCAN MURDER CASE.

The U. S. Supreme Court Refuses to Grant a Writ of Habeas Corpus.

WASHINGTON, March 30.—The Supreme Court of the United States has again refused to grant the application for a writ of habeas corpus which celebrated murderer Dan Dugan vs. McCall, Sheriff of Bopol County, Texas, in which it was sought to bring into question the constitutionality of the laws of the state of Texas.

Dugan was indicted, tried and convicted in Texas of murder, and sentenced to hang. He appealed the case to the United States Courts of Appeals, and the court there decided against him. The Supreme Court, in an opinion by Chief Justice Fuller, affirmed the judgment of the lower court from which the last appeal was taken.

Dugan's contention was that the code of Texas had never been lawfully enacted in accordance with the requirements of the constitution, that the code could not be construed in the event that it was enacted under authority of the legislature. It was then brought here. The Supreme Court, in an opinion by Chief Justice Fuller, affirmed the judgment of the lower court from which the last appeal was taken.

"The State of Texas," says the opinion, "is still in possession of its faculties as a member of the Union, and its legislative, executive and judicial departments are peacefully operating by the written and unwritten laws of the country." It adds:

"Whether certain statutes have or have not a binding force is for the State to determine, and no determination in that regard can affect the constitutionality of the United States, and raises no federal question giving this court jurisdiction."

## THE INDIAN.

Synopsis of the Existing Treaties Sent to the Agencies.

WASHINGTON, March 20.—The Commissioner of Indian Affairs has sent to the agents of the various Sioux agencies a synopsis of all the existing treaties and agreements between the Sioux and the government, including the Indian appropriations act, and the various acts of Congress.

The commissioner directs the agents to state to the Indians that Agent Cooper has been instructed to pay them \$100,000 per month, and that persons serving in the army during the late trouble and as soon as the information is received by the government, the amount will be paid to them.

They are also directed to request the agents have been informed that the agents have been requested to report to him what Indians are ready and willing to leave from their homes and other places, and as soon as this information is received the stock will be purchased and sent to him.
