DEMOCRATS ELECT HANSEN AND TOROUE.

From the Third and Fourth.

ATH. WESTERFIELD AND GRANT, HIGHJACKERS AND BUMBERS WERE IN THE FIRST, SECOND AND THIRD.

When the judges of the various election precincts of the city had finished their count of the votes last night cast for Board of Education nominees, it was definitely determined that four members of the old organization had been returned and only one new man chosen.

In the First precinct, Rudolph A. Heppenheimer, was chosen to represent J. T. Kingsbury, Democrat, in the number of 175 votes. The vote of each was, Kingsbury 418, All 500, Total 1,000.

In the second a very exciting contest was waged, E. H. Westerfield, Republican, had his forces well in hand and was victorious by 99 votes, while his opponent, Frank Grant, Democrat, was largely without organization or support. The former received 577 and the latter 425 votes, making a total of 1,000.

A canvas of the Third precinct resulted in a Democratic triumph with 510 and 490 votes respectively given to them. Paul K. Hansen, received 510 and Hansen, Democrat, 419.

A determination was also reached as to who was elected to the European Missions.

John M. Dalton has been unanimously chosen from laboring as traveling Elder to the Irish conference to solicit funds November 22, 1895.

Kingsbury was chosen to represent the Cheltenham conference.
