Ogden, Jan. 28 .-.. The Union Porttand Cement company which began operations about a year ago, having a large factory and properties in Morgan county at Devil's Slide, has decid ed to consolidate its interests with the Portland Cement company of Colorado, making a \$6,000,000 corporation to be known as the Cement Securities company. The stockholders have just been notified of this step, by the following letter:

EPIDEMIC OF HOG CHOLERA.

Pleasant View Pork Raisers Suffer Heavy Losses.

Heavy Losses. Ogden, Jan. 28.—Quite a number of deaths occurred among the hogs in Pleasnt View and vicinity, in the north-ern part of this county; but little note was taken of the matter until a day or two ago when one farmer lost 65 out of a drove of 85 on Saturday night. Prof. Frederick, veterinarian of the Agricultural college was sent for and he came down at once and pronounced the malady as hog plague, which is akin to cholera, if not the same as this malady. The disease, says Dr. Fredrick, is a germ disease, very diastrous to ani-

The disease, says Dr. Fredrick, is a germ disease, very diastrous to ani-mals and one of the most active con-tagions known to the animal kingdom. He states that the only way to get rid of it is to kill every hog that is found suffering from it and then to carefully and most thoroughly disinfect all the yards and premises where hogs are be-ing kept. The disease did not de-velop here but was carried here from the east through the importations of hogs here from there. The disease will not develop here but it will live and thrive here after it once becomes thor-oughly seated. sughly seated.

Cases of the disease have been reported from Boxelder and Cache coun-ties, and it may spread further if stringent measures are not adopted for its eradication

Exception the regular session held in the council chambers. Everything was serene and quiet until the communication from Mayor C. F. Decker disapproving the resolution giving all of the printing and engrossing to the Enquirer com-pany.
