TO THE INHABITANTS OF SALT LAKE CITY

The prevalence of diphtheria in this city and neighborhood seems to call for some action on the part of the quarantine authorities of the city to prevent, if possible, the spread of this disease. Though it is not deemed advisable at present to establish strict quarantine regulations respecting it, yet it is necessary to advise the adoption of such precautionary measures on the part of the inhabitants as will accomplish the object desired.

PREVENTIVES

As prevention is better than cure, it is the duty of all to guard against disease, and especially is it the duty of parents to guard their children under their care to see that they are protected, as far as may be, from the ravages of the contagion which is now so prevalent.

EXPOSURE

During the prevalence of epidemic diseases, children should be guarded against exposure to the infection. How to do this best will be our special rule, which will apply to all circumstances, but some general suggestions may be profitable.

CLEANLINESS

There is now prevalent in this city, among children, a throat disease, known as diphtheria, which is a most dangerous and contagious disease, and which, if not properly guarded against, may result in death.

HO FARMERS!

When diphtheria exists in a family where there are children other than those already infected, the disease should be guarded against by the most careful attention to cleanliness, and by the use of disinfectants.
