## "LIBERAL" TRICKS ATD TACTICS.

IT is evident that the boasts in which the "Liberal" leaders have lately indulged, that they were sure of carrying the election in February, like most of their statements are utterly false and made for effect. If they were sure "by actual count" of the victory they are so anxious to obtain, they would have no need to resort to the desperate straits to which they are reduced in order to curtail the votes of their opponents.

The tactics resorted to by the "Liberals" to obstruct, and if possible prevent, the naturalization of aliens supposed to be of the People's Party, and the dodges which it is known they have adopted to get aliens of their own partynaturalized, whether legally qualified or not, the efforts put forth to hinder and delay the registration of People's Party voters and to crowd on to the lists "Liberals," some of whom are not entitled to registration, and numerous tricks and subterfuges which they have either invented or enconraged, all go to prove that their "confidence" and "certainty" are mere bragging and deception.

The importation of miners and others for the purpose of swelling their numbers on the lists and on election day is notorious. They cannot keep these things secret, nor cover them with the dust they are trying to kick up about "colonizing." If every person who has come into this city to reside during the past few months is a "colonizer," what a huge colonizing machine is the "Lib ral" organization! Do these "Liberal" shouters think the people of Salt Lake City are blind? Do they imagine that nobody knows of the people who have not been in the Territory six months, who intend to register and to vote if they are not exposed and prosecuted? Do they fondly hope no one on the People's side has the sense to perceive the intent and the efforts of "Liberals" to get the names of sta-

The "Liberal" organ publishes what purport to be letters from different parts of the Territory, in relation to the men said to have come here to work and women said to have come here to board, and cook, and wash for men who have obtained employment in this city. And the inference sought to be drawn from this is that these persons are "colonizers," Well, what of it? The only question that is pertinent is, Have the men referred to, if such persons are here at all, come here to reside, to be citizens of Salt Lake. If so they had a perfect right to remove, they have a perfect right to stay, and if they have been bona fide residents of this Territory six months and of the precinct where they live thirty days previous to registration, they have a perfect right to be registered. The fact that they belong to the People's Party or the "Liberal" party, or no party at all, cuts no figure whatever in the question. Nobody is called upon to ask the "Liberal" chairman or the "Liberal" organ, or any official or unofficial "Liberal," permission to take up his abode in this city.

We do not know how many persons have lately moved into this city, neither do we care, so long as they have come here to be actual residents and have lived in the Territory six months. But if any of them who are not legally qualified to register and vote attempt to do so, we trust there will be vigilance and force enough in the People's Party to expose and prosecute such persons and those who prompt them or connive at their criminal conduct.
