EXTRA SESSION.

SENATE.

WASHINGTON, 3.—The report of the committee on privileges and elections on the credentials of Charles F. Bell, senator from New Hampshire, were taken up at the opening of the Senate.

Mr. Bell introduced a bill to authorize the President to appoint James Shields, of Missouri, a brigadier general in the army on the retired list. He also gave notice on Monday he would call up the resolution of Hoar, condemning the resolution of the policy, in order to bring the vote upon it.

After executive session, the Senate adjourned last Monday.

HOUSE.

WASHINGTON, 3.—The debate on the army appropriation bill was continued by Knott. He spoke of the great historical importance of the principle involved. He charged that the great fundamental principle of the Constitution, that the right of the people to elect their representatives should be protected from the slightest approach of military power, and that the vote should be cast by the people, and not by the military power.

He quoted an English statute of George II. for the removal of troops from the place where an election was to be held, and cited Blackstone, that it is essential that elections should be absolutely free and that no military force should be used to influence the result.

He had expected such a question would have been discussed on the other side with calmness and dignity, but in this hour of national grief and disappointment, he was disappointed.

He concluded his speech with a statement of the beneficent reforms that would be effected when the democratic party had captured the capital, as he firmly believed it to be in the hands of the people.

He did not intend his party to be led away from the question of the military power, but to the question of any collateral issue whatever, but it intended to move right on to the accomplishment of the high purpose upon which they were now engaged.
