The location was better and the arrangements and management showed a great improvement over the first exhibition.

Brette of Chicago, the question of deciding which was the best dog in the show was taken up, and after all had been carefully looked over, Judge Brette decided that the prize belonged to Quorr's Colonel, and the prize was accordingly awarded. The dog was picked as the best in the show and is owned by Quorr & Keefe of this city. Judge Brette said the dog compared favorably with the very best dogs in the world. **OCTUPLE SCULLS TO
BE INTRODUCED SOON**
New York, April 6.—To introduce octuple sculls rowing among the colleges of the country is to be one of the serious efforts of the American Rowing association. The stewards hope to have at least three or four teams entered for their annual regatta on the Schuylkill river at Philadelphia on May 23. To date the regatta has been the only one of its kind that has developed this style of rowing. Coach Ward intends to turn out another such eight this year. In previous years the Quakers have been obliged to secure their opponents for this race from the college rowing associations. The experience of the Poughkeepsie regatta has been to prove the great utility of turning out octuple scull crews. Every year Coach Ward forms his surplus rowers into octuple scull crews, and in addition to entering them in the American regatta they are used to race the varsity eight in its time trials. For this work they are far better than any number of second crews. Inasmuch as the stewards of the Poughkeepsie regatta are anxious to introduce this style of racing on the Hudson, the American Rowing association stewards expect the colleges which row at Poughkeepsie to take advantage of the opportunity. The regatta is beginning to receive orders or assurance of entries of many club oarsmen throughout the east. It is expected that the club crews will have a better representation than ever before. Bennett and Daly, the Worcester champions, expect to compete, while this city will send over its usually large delegation. The same is true of Baltimore and Washington.

State Treasurer James Christensen has filed his report for March with the state auditor. The balance reported on hand, March 1, was \$348,436.61, which with the month's receipts of \$281,290.78, made a total of \$629,727.39. The disbursements for March were general fund, \$77,944.50; state district school fund, \$398.72; fish and game fund, \$1,087.50; extermination of wild animals, \$1,242.67; trust fund account, \$67.48; principal and interest, \$17,760.61; total, \$98,688.35.

PARADES AT FORT DOUGLAS.


