

TESTIFIED ABOUT BRANCH AUTOPSY.

Surgeon Gatewood Gave Minute
Description of Midship-
man's Condition.

ORGANS WERE NOT ABNORMAL

Nothing Shown Which Disproved that
Injuries Had Been Caused by
First Blows.

Annapolis, Md., Nov. 28.—When the court-martial in the case of Midshipman Minor Meriwether, Jr., resumed its session today, Surgeon A. M. McCormick was recalled for the purpose of verifying his testimony.

Surgeon P. D. Gatewood was the first witness to testify as to matters connected with the autopsy. He gave a minute and technical description of the condition which the autopsy revealed in the case of Branch. He said that there was no fracture of the skull nor injury to the membrane of the brain except that brought about by the surgical operation. A large clot was found, however, under the membrane of the brain. The spinal cord, heart, lungs and kidneys were found in normal condition without evidence of previous ill health in these organs.

Surgeon Gatewood said that he believed that it was more likely that the injuries were received by Branch's head having come directly in contact with some hard object rather than by flat blows. In his opinion, the primary cause of death was hemorrhage. It increased the fluid outside of the brain substance caused death.

FOR PRESIDENT'S POLICY ON RATE LEGISLATION.

Washington, Nov. 28.—It developed today that the subject under consideration at the White House conference last night, which was participated in by the president, Secretaries Root, Taft, and Bonaparte, Senator Knox and Commissioner of Corporations Garfield, was the projected legislation affecting freight rates. It has been positively decided that there shall be no further expression of the administration's views on this subject pending the publication of the president's message to congress, in which it is treated at great length.

It is also learned that there has been no change whatever in the president's view as to the best form of rate legislation. In other words, his views have not been affected by any of the propositions recently made public.

Senator Doolittle of Iowa, a member of the committee on interstate commerce, talked with the president briefly today. After his interview the senator remarked when asked about rate legislation:

"We are moving along toward a practically unanimous stand for the president's policy."
Representative Hinchshaw, of Nebraska, who also talked with the president, declared:

"The people of Nebraska are unanimous in support of the president's positions to rate legislation."

McCLELLAN WILL AID HEARST.

Will Make no Appeal Against Opening
Ballot Boxes.

New York, Nov. 28.—Mayor McClellan today gave promise of his efforts to William R. Hearst to have the ballot boxes in New York's recent majority election opened and the ballots recounted. He announced that he had directed Alton B. Parker, his attorney, not to appeal from the decision of the supreme court yesterday, which ordered five ballot boxes to be opened.

WARM IN CHICAGO.

Chicago, Nov. 28.—Never since the establishment of the weather bureau has a day so warm as this been recorded in November. The mercury this afternoon reached 68 degrees. Early in November, 1888, the mercury touched 75 degrees, which is the record for November weather in this city. Today was the second warmest day ever known during the month and by far the warmest for the latter part of the month. A fall of 40 degrees is predicted by the weather bureau by tomorrow.

CLAIMS FOR GOLDDUST.

Seattle, Wash., Nov. 28.—A special to the Post-Intelligencer from Fairbanks, Alaska, states that three banks of that place will make claims against the government for gold-dust which they shipped to the Seattle assay office on their own account and for miners in that district. The aggregate of these claims, it is estimated, will amount to approximately \$100,000. Of this sum the Fairbanks Banking company has a single claim for \$20,000, representing the shrinkage alleged to have been reported on a series of large shipments last spring.

FIVE REPORTED DROWNED.

St. Paul, Minn., Nov. 28.—Special to the Pioneer Press from Duluth says: The schooner George Herbert was sunk off Two Islands, on the north shore, and it is reported five men were drowned.

PERKINS' FATHER MAY KEEP HIM OUT OF JAIL.

Portland, Ore., Nov. 28.—An offer to settle the amount of the deficiency and save Fred H. Perkins from the penitentiary is to be made by Perkins' father. Perkins is wanted at Salt Lake City in connection with an alleged embezzlement of \$15,000 from a mining company. Perkins' attorney today held a consultation with Gov. Chamberlain of Oregon as a result of which the executive stated that if Sheriff Emery, who expected to arrive from Salt Lake City tomorrow, insists on Perkins' return a hearing before the governor must be had before final action is taken.

NOTED JAPANESE WRESTLERS.

Kodimir and Komugatake Will Make
Tour of America.

Victoria, B. C., Nov. 28.—Troops were arriving daily at Tokyo when the Iyo Maru sailed.

Field Marshal Oyama and Gen. Kodama were expected shortly, having been ordered to Tokyo by the emperor before he proceeded to the temple of Ise to give thanks to the imperial ancestors for victory.

The Iyo Maru brought news that a group of famous wrestlers, including the noted Kodimir and Komugatake, who have made a successful tour in Korea and China, will shortly start on an American tour. They will leave for San Francisco shortly.

A number of members of the Japanese diet have been arrested at Tokyo in connection with the anti-peace disturbances.

A Peking dispatch to the Tokio Asahi says an agreement has been made by the governor of Shantung province with the German government, general of Kiao Chou, for the withdrawal of German troops from Shantung. The evacuation is to be complete in six months, when China will purchase the German barracks at Kiao Chou.

The Japanese squadron to visit England will consist of the cruisers Asama, Tokiwa, Chitose and Kasagi.

The Toyo Kisen Kaisha's service between Japan and South America will be commenced on Dec. 6, when steamer Glenfarg will leave Yokohama for Galapagos.

A copyright treaty between Japan and the United States was signed at Tokyo on Nov. 11.

The Nippon Yusen Aisha line is arranging for more frequent services on its American-Australian and European lines.

Chicago, Nov. 28.—Samuel N. Hoffheimer, a nephew of Nelson Morris, the millionaire packer, was arrested here tonight, charged with having swindled S. W. Strauss & Co., mortgage bankers, at 114 La Salle street, out of \$250,000.

Being unable to furnish bonds fixed at \$150,000 by Justice Cochrane, who issued the warrants for the arrest, Hoffheimer was taken to the Cook county jail. The alleged swindle operated by Hoffheimer extends over a period of 18 months. His relations with the Morris family, it is said, made it possible for Hoffheimer to carry out the scheme for such a long period without detection. Two years ago, while the young man was carrying on a small commission business in buying and selling cattle feed, it is alleged he went to S. W. Strauss & Co. and explained that he was buying large quantities of cottonseed and cottonseed hulls which he disposed of to Nelson Morris & Co.

In order to carry on the business, it is alleged, he explained that a large amount of money was necessary to take up the drafts which were made daily on him for the feed and to take up the bills of lading made with the shipments. He, it is said, requested S. W. Strauss & Co. to finance the deals, which they agreed to do.

From that time on, it is alleged, Hoffheimer daily delivered lists to Strauss & Co. of carloads of cattle-feed which he said he had bought from various concerns and sold to Nelson Morris & Co. He would obtain checks for the amount of his purchases from S. W. Strauss & Co. and at the same time he would deliver to the bankers a draft on Nelson Morris & Co. for the amount for which he had informed them he had sold the feed to the packing company. The draft taken by the bankers was deposited in their bank in the usual course of their business.

At the beginning, according to the bankers, Hoffheimer carried on only small sales; but the amounts of the transactions grew so that sales to Nelson Morris & Co., as reported by Hoffheimer, amounted to more than \$150,000 a day. Until the first of this month the supposed sales continued, and then it was learned, it is said, that all the sales were fictitious. Instead of taking up the drafts which he had said were made out against him when he bought the supposed feed, Hoffheimer took up the drafts which he gave to S. W. Strauss & Co. against Nelson Morris & Co.
