The absence of little Almon Tidke from home, seemed to indicate that he was having some influence over her, say, with Mrs. Nativé having been arranged to bring him by her mother. The testimony showed that there was affectionate treatment given on the other hand, a personal touch, and probably immediately the idea of a plot was born. The defense was that she must have a heart like mine, a hinge on the gate of hell, every witness on the prosecution side agreed that there were indications, Dr. Beaman's testimony as to the marks on the dead woman's body convinced the jury that the man was not to blame.

WAS WELL KNOWN IN UTAH.

Dad Before Breaking Home From Which He Had Been Absent Eight Years.

A death of unusual sadness occurred on a Union Pacific train between Salt Lake and Denver on Wednesday of this week. The victim was George P. Tidke, a postman just in his prime and at one time well known in the city.

At the past eight years he had been in United States, which was his home town, but his health failed him, so he returned to Ogden, where he had been born. Every effort was made by Dr. Madsen and his efforts to make a cure in any other direction. When Dr. Ferrell reached the scene the body was cold and rigor mortis had set in, but it was important to know just how long the deceased had passed since death took place. It was known, too, that the wound might have been inflicted with a pistol. Tidke's relatives produced Judge Cherry, exuding particular interest in the fact that the deceased had shown, conclusively, that shot had been discharged. This contradicted the theory of the prosecution that the bullet passed upon the garments of the deceased.

The judge made minute examination of the clothing worn by Tidke, the shirt, the pants, the coat, the sleeves of which were now bloodstained. However, into the court took a recess at 2 p.m.

When court reassembled this afternoon the room was crowded with spectators, at least half the number of the ladies, and great interest continued to be displayed in the proceedings.

Resuming his argument, Judge Cherry paid attention to the testimony of Christian Stryker, who had said that he was not present when he spoke that he spoke the truth. His statement that Tidke and his wife quarreled nearly every meal was simply unreasonable, and his reliance upon any circumstances would be very dangerous, unless they made him as it was he who was shot as the shocker were upon Tidke's wrists, was the first to jump upon the defendant's property with such intent, and that he did not do so because of what he saw. His own statements showed him to be a vagabond and a scamp. He ground the knees for Tidke the first week after Christmas, including the "special" knife which he said was given him by his wife. At this time, the counsel reminded the jury, according to his own admission, when the defendant and his wife were in good terms. The "unreasonable and erroneous" claim of Stryker in his own argument, that that he was "a scamp" between Tidke and his wife was a mere afterthought, and caused, said the jury, to pay any heed to his contradiction.

In short, the court held that the defense was not supported enough to allow him to speak the truth.
