ALBANY NEWS.

New York, 26.—From the Tribune: Ex-Senator Conkling, who was in Washington yesterday, telegraphed Platt that he would reach Albany tomorrow night and that Conkling will go to Albany tonight to continue their hopeless fight for the senatorship which they resigned.

Vice-President Arthur will also return to the State capital to assist Conkling in any way he may direct.

The relations between Platt and Vice-President Arthur have not been cordial since Platt defeated Crocker in the race for the senatorship last winter. There is also a strong authority for stating that Conkling and Platt are not cordial in their relations to the public mind.

They frequently go to Albany on trains only a few miles apart and return in the same way, apparently without purpose, not being thrown together any more than is necessary.

A friend of Conkling said yesterday the ex-senator depended a good deal upon the Vice-President's assistance, and very little Platt might do. It appears that Vice-President Arthur charges the downfall of the machine upon Platt.

He says Platt, to make sure the defeat of Crocker for the Senate, and to secure his own election last winter, entered into an agreement with administration republicans to support Judge Robinson to-day office for which the President might nominate him. This was made known to the President, and General Arthur is understood to have said that without this agreement Judge Robinson would not have been nominated for collector of the customs at New York.

Further, it is stated that the first discussed with Conkling, who would not then have felt called upon to resign. Ex-Senator Conkling now it is said begins to view the matter with a somewhat lighter eye.

The Vice-President and there are rumors growing of a willingness on his part to make Platt a scape-goat. There is a growing opposition manifested by republicans towards Governor Cornell.

A distinguished member of the wing of the party said yesterday, "I do not dispute the fact that the governor does not longer sympathize with Conkling. He refused to attend a conference the other night at which Conkling made his anti-monopoly speech. What the governor would do in the long term, Conkling, however, has ceased to place any confidence in the governor."

Conkling went to Washington, according to one of his friends, to attend to some personal affairs, among other things to surrender his name that he does not expect to be re-elected. This friend said he only hoped to throw the contest over to another legislature, and thus be able to return and dictate his successor. Platt said yesterday that Depew would be out of the race this week, after the legislature would adjourn without electing any one. He made a similar prophecy a week ago.

A member of the committee which investigated the Bradley charges, Senator Benjamin, said there would probably be three reports made—one by Conkling, one by the committee, one by the administration republicans and one by democrats. The last two reports he thought would not materially differ, but the salary report, he believed, would be a surprise.

Platt seemed to think this report would end Depew's canvass in the same way as he thought the "original charges" would end it. It does not have any more effect than the charges, it will probably increase Depew's vote. Ex-Senator Conkling will give his personal attention to the preparation of the report.

Senator Strahan was the only republican who called on Platt yesterday. He has acquired unpleasant notoriety since Depew's testimony, and his friends are threatening vengeance on Davenport on account of it.

There is a general impression that the election will take place on the week. Combination are more talked of than heretofore by returning legislators. The democrats are making the most of the point that there was no legal ballot on Saturday, and an election by this legislature will be vitiated.

It is believed that Conkling will be in league with the republicans, and if the democrats attend the joint assembly it is proof that they consider the election valid. The Pennsylvania election is also cited as refuting this theory.
