

Mr. Empey kindly informed the managers that he would render them all the assistance in his power to them all the assistance in his power to make the place desirable for the popu-lar sport. The grounds are very con-venient, being reached by two car lines and situated in almost the heart of the city. The Belgium terminus will be La Panne, near the French frontier. The line will be about 74 miles long.
