An Ingenious Invention.—Last Thursday we were shown a very ingenious machine for cutting mince meat, hash, etc., invented and made by Mr. E. E. Taylor. It consists of an upright bar on the lower end of which is a knife that is raised with exceeding rapidity by means of a crank and levered each time with considerable force by means of a spring. This bar, spring and crank are arranged in a frame at the bottom of which is a revolving receptacle for meat or anything desired to be chopped fine. The machine works with rapidity and ease, and would doubtless reduce to hash in short order anything put under the knife.

A Suggestion.—As the advance sales for the opera season already indicate large audiences at the Theatre next week, would it not be a good idea for the enterprising Superintendent of the Street Railway Company to run special cars for the occasion?

Our streets are in a bad condition for travel now and may be much worse in a few days. This is indeed a heavy blow, and the family have our warmest sympathy. None of the rest of the family are at present afflicted with the terrible disease, but a neighbor, John R. Powell, we understand, has one child down with the contagion, but we were unable to learn whether her condition is dangerous or not. Due precaution should be taken to prevent spread of the malady.

## SEABOLD'S EXAMINATION.

BEFORE COMMISSIONER MCKAY.

There is a great deal of interest manifested regarding the D. & R. G. accident.

This will probably prove the most important case of the kind that has been brought up in Utah. Seabold was taken before Commissioner McKay yesterday afternoon for examination.

The prosecution is brought under the testimonial statutes on a complaint sworn to by Captain Hawley, a D. & R. G. detective, which charges Seabold with criminal negligence.

Judge Harkness assists Mr. Varian in the prosecution. The defendant is not represented by counsel.

Mr. Seabold realizes the extent of his carelessness and feels extremely bad.

The Railroad Company will, in all probability, have to pay out heavy sums of money to those dependent upon the men who were killed and to those who are crippled, saying nothing about the damaged rolling stock and expense in picking up the wrecks, etc.

Mr. Osterwald, the engineer who was on the work train, says he did all in his power to avoid the collision. He is deeply grieved over the result.

Geo. D. Gray, conductor; A. N. Russell, engineer; Fred Breckenridge, Theodore Finch, brakeman; all of the freight train; Herman C. Osterwald, engineer; John Griffin, fireman; Brigham W. Nelson, brakeman; of the work train; Charles A. Hawley, detective, and John Welch, foreman, of the laboring men were examined. Their testimony was in substance the same as given at the Coroner's inquest. Adjourned till this morning.

The investigation in regard to the D. & R. G. disaster was called before Commissioner McKay this morning at 10 and Seabold held in \$1,000 bonds for his appearance on Monday next at 10 a.m., to which time the case was adjourned. The defendant was endeavoring to secure bail for his appearance when our reporter left. Sheets and Rawlins have been retained as counsel for the defendant.

Rasmussen vs. MacKnight.—Yesterday afternoon was occupied by the trial of the case of Rasmussen and others against Jas. MacKnight et al. MacKnight defended himself, while Arthur Brown, Esq., appeared for the prosecution.

The case appears to be founded upon the allegations that Rasmussen had a claim of property he wanted to sell for \$470, and that MacKnight bought it, giving \$100 down and a note and mortgage for the rest, but that there appeared fraud and crookedness in the drawing up of the last named.

Mr. McKnight, defendant, complained that the prosecution had six witnesses to his one. He claimed that previous to the commencement of the suit arrangements were in progress to make things satisfactory to both parties, but owing to a "sudden catastrophe" occurring to the plaintiff, the suit was instituted. He attempted to show that the plaintiff was trying to perpetrate a fraud in endeavoring to regain the property and improvements that defendant had made. He made a lengthy and exhaustive defense, to show that the transaction was straight and legitimate, but failed to straighten in the judge's mind the crookedness shown up by the prosecution's witnesses.

After he finally closed, Judge Zane gave a careful review of the case and testimony, holding that it was a clear case of fraud. He blushed to think that one of the legal profession should be guilty of such a transaction and advised him to abandon the profession and disgrace it no longer. He then granted a decree as asked in the complaint. The defendant accepted the ruling of the court, and ten days were given for him to comply with the decree.

Another Burglary.—Early yesterday morning, Mr. J. H. Midgley, on entering his store in the 12th Ward, found the door open and goods to the amount of \$20 or \$30 missing, besides some change left in the money drawer. An entrance was effected by means of a broken glass in the door. Through the aperture it was an easy matter to open the door and walk in. They helped themselves to canned fruit, tobacco, Christmas cards, groceries and sundry articles which it seems were carried away in a vehicle as one or two cans were picked up near the wagon road. Some time ago the party missed a small amount from the cash box. These incidents prove the necessity of increased vigilance on the part of all that have anything to lose. If a few of these housebreakers could be met with the proper kind of a reception, their marauding expeditions would become less frequent.
