WE publish today an interesting and pointed communication from Mr. David L. Murdock. The gentleman pays his respects to the Utah Commission, a body chiefly conspicuous for official manipulation, the object of which is to render political frauds not only possible but absolutely certain. Their chief occupation—as a majority—has been to pursue a course of action that would render their existence perpetual. It may transpire one of these days, however, that these gentlemen have reckoned without their host, the majority of the people of Utah, whose rights have been invaded by their one-sided administration.
