In part he said, it was with very peculiar feelings he attempted to speak, as he felt that the occa-sion was one on which all who knew Prest. Flygare mourned realizing the loss of a worthy brother, friend and acquaintance; a man who was a true supporter of the cause of God, whose life had been one of missionary work both at home and abroad. It was 25 years, the 20th of last January, since the presidency of the Weber stake was crganized and the deceased was select-ed as second counselor, and continucrganized and the deceased was select-ed as second counselor, and continu-ously their labors had been of love and good fellowship.
