**DR. JANSEN GIVES LECTURES.**

The Explorer Thinks There is a Land at the North Pole.

Dr. Nansen's Northern Will seek and for the North Pole in June. The journey will be through, taking straits to the new Siberian Islands where he expects to run open water in August or September. "Should the ship sink," says Nansen, "we will save ourselves by shooting our tents on the ice. We are again prepared, we propose to go by boat." The crew is to consist of twelve men with provisions for five years. Dr. Nansen thinks that the journey can be made in much shorter time, possibly in two years.
