MORE ABOUT PAINE'S NEW LIGHT .- The Worcester Spy, whose account of Paine's most recent discovery we copied, adds the following information on the subject:

"At the time we penned the article referred to, we were not permitted to give any explanation of the nature of the process, but we are now permitted to state, that the atmosphere is passed cold, through a simple apparatus containing a liquid that absorbs the nitrogen of the air, leaving the exygen free; then the pure oxygen is passed through another fluid, by which it is catalysized, and rendered highly luminiferous. It is not a process of evaporation, for the gas is conveyed to any distance without condensing, and no heat is required in the process of catalysizing. The process is not like the passage of air through benzole or other fluid carbons, according to the process so well known to chemists; for in such cases, the rapid evaporation cools the liquids, and then the luminous action ceases; while in this, the action is the same through any required length of pipe, or any number of burners.

"Mr. Paine has made us acquainted with the materials used in producing the astonishing results which we have described, of converting atmospheric air into a purer and better gas than is furnished by any gas company in the United States; and from what we know of their cost, and what we have seen of their consumption in the production of light, we think the expense of a light from a common argand burner could not exceed one mill or so per hour. Mr. Paine informs us that he succeeded, two years since, in producing a brilliant light by his present process; but on account of some difficulty connected with the mechanical passage of the air through the apparatus, and the occupation of his mind with other matters, he temporally abandoned it. But now, all difficulties are obviated, and the apparatus is in complete and successful operation in different places. The apparatus for lighting a large house, will occupy but little room, scarcely more than a large sized gas metre. Men of science, and gas company directors have, within a few days, given the whole matter a thorough investigation, and so far, there is but one opinion in regard to the invention, viz.: that it is the one thing needed to give a safe, unfailing supply of light at a merely norminal expense, free from all danger of explosion, and accessible to the use of all."
