Practically Impossible for Oyama To Envelop and Crush Kuropatkin.

### SO DECLARES BARON HAYASHI.

Retreat on Part of Russians Now Would be an Admission That They Had Been Beaten.

London, Oct. 13.—News of the battle between the Russians and Japanese was eagerly awaited here throughout the day at the Japanese legation. Many inquiries were made there by British officials, but the Japanese authorities were even less informed than the newspaper. The suspense was not untinged with anxiety, which was more noticeable than almost any previous phase of the war. Baron Hayashi, the Japanese minister, said to the Association Press:

"The reports of our successes, welcome as they are, must not be construed as being a forerunner of any decisive blow. It is practically impossible for Marshal Oyama to envelop and utterly crush Gen. Kuropatkin, just as it is practically impossible for Kuropatkin to envelop Oyama. A victory in the battle now raging might mean to us that Kuropatkin must confess defeat, which is impossible. He can push forward no strategic cause at Liao Yang."

New York, Oct. 13.—Testimony in the contest over the will of Bertha Marion Dohler of San Francisco, who leaped from a ninth-story window of the Waldorf-Astoria on the night of July 9 last, and who left \$750,000 of her \$2,000,000 estate to her cousin, Eliza Marion Warren, was taken today before Commissioner Robert P. Lee.

Carter Gustav Scholer, while on the witness stand said that Miss Warren had told him of the tragedy soon after it happened. Miss Dolbeer had been complaining of the heat and Miss Warren went in the corridor. They returned to their rooms, but as Miss Dolbeer still complained they went out in the corridor. She was in the lead, and Miss Warren's skirt caught, and looking up again she saw Miss Dolbeer vanishing out of the window.

"It is impossible," concluded Baron Hayashi, "to think that this war can be allowed to continue indefinitely. Intervention in some shape or form must eventually occur. At this moment Russia dreads any one suggesting it, because therein is involved a confession of defeat. Should Port Arthur fall I think it would be different."

London, Oct. 13.—The London papers have to rely mainly upon official reports for news from the far east, but the dispatches thus far received regard a number of topics which were not mentioned in the original article and editorial from this point of view. Says the Daily Telegraph: "Gen. Kuropatkin has shot his bolt. He seemed to be spending well toward the mark, yet has missed it badly. He has suffered not merely a repulse, but a disastrous defeat, whilst Japan's incomparable soldiers under incomparable generals have added another glorious page to the chronicle of war and proved that Oyama is still Kuropatkin's master in every branch of the art of war."

The Daily Graphic describes Gen. Kuropatkin's覆面 as a "gambler" and adds that the frank bluntness of his report to the emperor seems to speak the language of a man who has done his best with the bungling advice of some superior agency.

The Standard finds Gen.
