

UTAH LEARNS ITS FOOTBALL LESSON

Weaknesses of Team Show Up
In Early Season Game
With Denver.

POSSIBILITIES ARE GREAT.

The Line Is Stronger Than Ever While
Conville Is Successful In
Bennion's Place.

The team as a whole is a classy one, which promises to uphold Utah's record of previous years.

The mighty Bennion has a good successor in Conville, whose booting is excellent, but at present a trifle slow.

Palm and Seelye give the pair of heavy guards so essential to a well balanced team, strengthening these positions over any year since 1904. Peterson and Brown at center were neither remarkably successful, and this position with that of the quarterback seems to be the most noticeable place of possible weakness.

The first game, played in warm weather, with a new ball, much harder than that used in practice, caused ragged handling of punts, which became almost a feature. Initiative is not yet playing its form, as is the receiving of the ball on long passes, and especially the catching of punts, according to me, was not attempted.
