St. George, Jan. 15th, 1867, 9.30 p.m.

Pres. BRIGHAM LOUNG,

To day at twelve o'clock, Mr. Stickney with his party, who have been stringing the wire from Scipio, Round Valley, arrived here. When within three miles of the city, he was met by the St. George cavalry, under Captains Pearce and Andrus, who have just returned from the south east, having recovered the stock that was taken by the Navajoe Indians, and a large party of citizens in carriages, wagons and on horseback, and escorted to the city where the people had assembled to the number of about one thousand to witness the completion of the Deseret State Telegraph. The wire was run into the St. George hall, in order that as many as possible should witness the receiving of the first dispatch from their President. When the last connection was made, a salute was fired by Captain Crosby's artillery, and the St. George brass band, led by our old friend Charles J. Thomas, who formerly led the orchestra of the Great Salt Lake City theatre so well, played lively airs: speeches were made by Bishop Gardner and others, and the day was set apart as a holiday for the city. The bishops and leading men of nearly all the southern settlements were here, and a feeling of universal gladness is manifest on every side. With the exception of a few trifling changes the Deseret State Telegraph is now complete, and in fine working order from Logan City, Cache Valley, to St. George in "Dixie." The operators take pride in attendingpromptly to their business, and we may safely pronounce this telegraph line a decided success. Robert Lund remains here as operator and is a young man of good ability.
