## ANOTHER "MORMON" EXODUS."

THE American press is once more teaming with notices and comments about the wholesale exodus of "Mormons" from Utah into Mexico. They are reported to be moving there by the thousan is, and the impression sought to be made is, that this Territory is to be evacuated by the Saints and to fall into the hauds of the Gentiles.
