future assessments. The reasons  
for adopting this rule were clearly  
set forth by Bishop John Sharp, in  
a few timely and pointed remarks  
on the subject. Brief addresses were  
also delivered by Messrs. Pugsley,  
Jennings and Little, and also by  
the chairman of the meeting.

The proceedings were character-  
ized by the most perfect unanimity  
of sentiment, and the feeling that  
predominated was not only warm  
and generous, but also enterprising,  
and a true sense of the necessity of estab-  
lishing an enterprise of the kind under  
consideration, which must be ap-  
parent to the most obtuse, but also  
as to the ultimate success of the un-  
derstanding. The elements of suc-  
cess, with but few exceptions, for  
the purposes of the branch of man-  
ufacture contemplated are here in  
abundance, and the gentlemen who  
from the present organization, are  
nearly all men of experience, busi-  
ness tact, energy and enterprise,  
capable of carrying the matter for-  
ward to a successful issue.

The chairman intimated that the  
Bishops and their counsellors, of  
the several wards of the city, would  
be expected, in the meantime, to  
act as committees to obtain the  
names of all who purposed subscrib-  
ing stock and the number of shares  
each person proposed to take, that a  
clear and definite report may be  
rendered whenever necessary. He  
also explained that it was desirable,  
as far as could be, that the people  
generally should be interested in  
the enterprise, by taking stock in it.

The meeting adjourned sine die,  
subject to the call of the directors.
