Whereas, said Act, beside being a direct invasion of the people's rights, and in conflict with the first Amendment to the Constitution, is ex post facto:

Therefore, We, your Memorialists, respectfully ask your Honorable Body, for the reasons briefly stated, to repeal the prohibitory provisions of said Act, and to leave the people of this Territory free to exercise their religion and its ordinances as guaranteed by the Constitution, believing that in so doing, you will best promote the peace and welfare of the country, and frown down the insidious attempts which are being made to array the inhabitants of one section against those of another, because of differences in religious belief. And your memorialists, as induty bound, cent. will ever pray.
