The Union Pacific, Mr. Curtis added, had threatened a tier the conference to reduce its rates from the east to Utah as a offset the reduction to be made by the Southern Pacific. The Southern Pacific's reduction would amount to the same rate per mile, except for some lines of goods, as the rate from the Missouri river to Salt Lake City.

There seems to be no doubt now of the Southern Pacific's determination to reduce rates. Its freight department feels confident of being more than a match for the Union Pacific in any rate war the latter might attempt.
