## UTAH LAKE RESERVOIR.

#### Strong Opposition to Project-Court Cases-Death of J. Gledhill.

Special Correspondence. Provo, Feb. 6 .- The county board of commissioners, County Physician G. H. Robison, Dr. J. H. Slater and Attorney Jacob Evans met today as a county board of health.

The purpose of the meeting was to protest against the raising of the waters of Utah Lake as proposed by Salt Lake City and others. The board all agree that the raising of the lake would bring about a most unhealthy state of affairs, as the drainage of the Utah ounty towns would be greatly injured, and for that and other reasons the board will fight the proposition from sanitary standpoint. The commissioners themselves are aroused and will

do everything legally to prevent the execution of the project. "The fololwing resolutions were preented to the board by the committee.

"Whereas, It has come to the knowledge of the board of health of Utah Utah, that certain in-and the corporation county. dividuals and the cor of Salt Lake City, and count ty, intend to raise the waters of Utah Lake to a point five feet above the ompromise point, which point is ap three feet and three and one-half inches

above low water mark; and "Whereas, It is the opinion of the said board of health that if said indiv-

iduals or corporations or any person whatever raise the waters of Utah Utah Lake to a point five feet above the ompromise point, or raise the waters of said lake to a point in excess of said compromise point, it would cause numerous stagnant pools of water to form and raise the ground water nearer the surface of the earth and prevent a proper drainage into said Utah Lake. thereby favoring the generation and

spread of disease, and in our opinion would be highly injurious to the public health of the county. "We, therefore, recommend to the

commissioners of Utah county, Utah, that they take such steps as are necessary to prevent the raising of the waters of said Utah Lake, by any per-



# BURIAL OF A SOLDIER BOY.

### Impressive Funeral Services Over Remains of Albert W. Hartvigsen.

Special Correspondence. Sandy, Salt Lake Co., Feb. 7 .- Yes-

terday at 2 p. m. in the Sandy ward house the funeral services were held er the remains of the late Albert W. Hartvigsen, who died from a gun shot wound accidentally discharged by one of his comrades in Manila on March Deceased was 19 years old 10th, 1899. and born in Sandy. The body arrived on the Oregon Short Line last Sunday morning. The services were con-ducted by Bishop Kuhre. The remains were inclosed in a zink-lined casket, hermetically sealed, the outside being covered with black cloth. On the asket were some beautiful flowers, one of which was an emblem consisting of a harp covered with natural flowers, with a picture of the deceased in the center; this was presented by Mayor Robertson in behalf of the city. pall bearers were six of the recruits of his own regiment and presented a very fine appearance.

The services were opened by singing from the ward choir. Prayer was of-fered by President James Jensen of the Jordan Stake. Addresses were made by Bishop Kuhre, followed by one of the battery boys, and Elder Byron Beckstead of South Jordan. All spoke very feelingly of deceased, especially his comrade, who spoke highly of his good qualities, his courage and faith-fulness to duty, being always at his

The choir sang the closing hymn, "Nearer my God, to Thee." Benediction was offered by Counselor Wilson, after which the remains were placed in a hearse and drawn to the Sandy cemetery, about 100 vehicles following the remains. The coffin was placed in a strong redwood box of one and one half inches in thickness, and lowered in the grave. The dedicatory prayer was offered by Counselor Crapo, after which three volleys of guns were fired over the grave by 10 boys of the Utah battery.

The ward house was filled to its utmost capacity, every available space was occupied, and between 700 and 800 persons attended. All the business houses were closed during the funeral services, in obedience to the mayor's proclamation.
