

## WASHINGTON NOTES.

A report will be made to-day or to-morrow under a suspension of the rules in the House, to pass a resolution, directing the committee on elections to make a report in the case of Bishop Cannon, of Utah. It seems to be the determination to unseat him before adjournment if possible; at all events, to get the case before the House. It is understood that this war upon Cannon is being carried on by the parties in Salt Lake city who have some private axes of their own to grind if they can get the upper hand in Utah through Congressional interference.—*Washington Star, June 17.*

**CANNON WILL NOT GO OFF.**—Delegate Cannon, of Utah, is now safe from expulsion from Congress. An attempt was made to-day to get an order of the House, under a suspension of the rules, permitting the minority of the committee on elections to report on Cannon's case. This motion got but little support, and no further effort will be made to molest Mr. Cannon.—*Chicago Times Telegram.*

House, Washington, 16. — Mr. Smith, (N. Y.,) from the committee on elections, reported a bill declaring the qualifications for territorial delegates in the House of Representatives. [The bill requires that no person shall be a delegate who is not twenty-five years of age and has been seven years a citizen of the United States, and when elected an inhabitant of the Territory from whence elected, and no person guilty of bigamy or polygamy shall be eligible.]

Mr. Cox, (N. Y.,) asked if that affected the present delegate. Mr. Smith said the legal effect would be proscriptive, but at the suggestion of Mr. Cox consented to insert the word hereafter, and as thus amended the bill was passed.—*Washington Star.*

Washington, 16.—The House under suspension of the rules and without considerable opposition, passed a bill declaring that polygamy shall render a delegate ineligible. The word "hereafter" was inserted, which exempts Mormon apostle Cannon from the operation of the act.—*Cleveland Herald.*

The impression seems to be gaining ground that Congress will not be ready to adjourn on Monday next, for the reason that there is much business of importance before it which it will hardly be possible to dispose of by the time mentioned. Among the important measures remaining to be acted upon are the currency, moiety and several appropriation bills, also the bill to provide a government for the District of Columbia. All of these measures will evoke considerable discussion, and it is doubted if they can be disposed of as early as Monday next. A strong effort will be made, however, through night sessions and extra work, to dispose of the business on hand for an adjournment on that day.—*Washington Star, June 15.*

WASHINGTON, June 14.—Hundreds of visitors are now here on business with Congress, interested either in public measures or in bills for the relief of individuals. They are daily to be found at the doors of the two houses and in the ante-rooms. Members are all the time being called out in response to their cards, while not a few receive importunate visitors at their residences.—*New York Herald.*

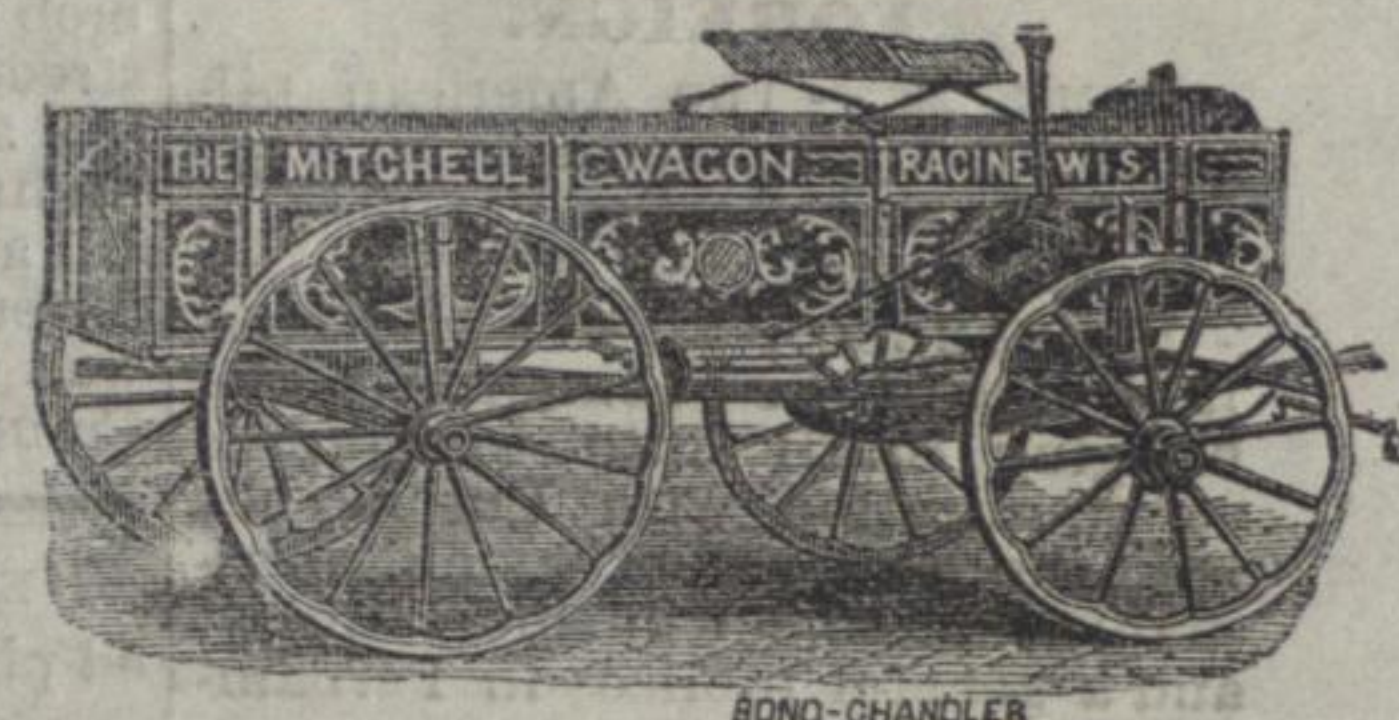
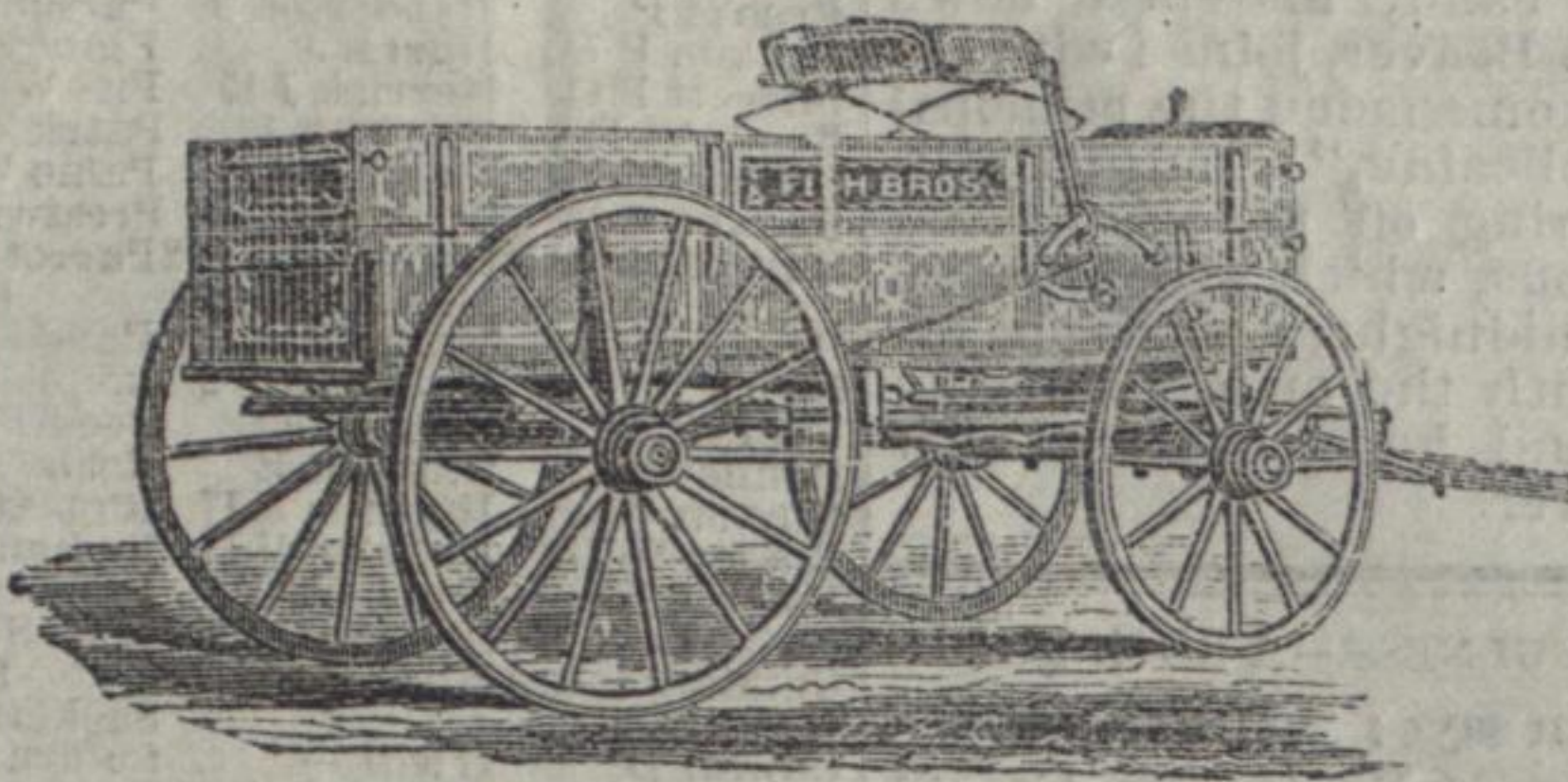
