# "AMERICANS" STAY BY GEORGE SHEETS

Voted Solidly Against R. S. Wells  
Resolution to Remove Chief  
Of Police.

## HIS FRIENDS WERE SILENT.

All Speeches Made by Wells, Fernstrom  
And Preceded by Exception of Hob-  
day's Name Apology.

As was anticipated, the "American" members of the city council to a man voted to sustain Chief of Police George Sheets when an attempt was made to have him removed from office last night.

The matter was sprung as a surprise on the administration councilmen by Councilman Wells, who introduced a resolution reciting the resolutions made at the preliminary hearing of Sheets which resulted in his being bound over to the district court on the charge of criminal conspiracy and then calling for his removal from office for the good of the service.

With the exception of a short talk by Hobday not a word was spoken by the "American" councilmen in defense of the man who was alleged to be connected with a conspiracy with crooks and hold-ups for the purpose of robbing tourists in this city and who is also alleged to have been connected with the men who robbed the McWhorter brothers of more than \$10,000 last September. They had nothing to say but when the time came to vote they all went on record as opposers of the resolution.

Fernstrom made strong arguments in favor of the resolution and urged that even though Sheets should be proven innocent of the crime charged, he should be removed from office because he did not secure the arrest of the men who committed the crime after he had such a good opportunity to do so.

Whereas, Without objection, the resolution is hereby adopted, and the resolution was defeated by a vote of five ayes and nine nays.

WELLS' RESOLUTION.

Just before the close of the council meeting Wells introduced his resolution which follows in full:

Whereas, Chief of Police George A. Sheets has been charged with a serious offense against the peace and dignity of the state and city;

Whereas, Without objection, the resolution is hereby adopted, and the resolution was defeated by a vote of five ayes and nine nays.

Therefore, Be it resolved that said Chief of Police be removed from the office of chief of police for the good of the service.

Wells immediately moved the adoption of the resolution and a roll call was asked for at once. Black was the first name called and in casting his vote he merely explained that the matter was in court and should not be acted upon until the case against the chief had been decided by the court.
