A divorce suit from Park City found ready to the files of the Third District Court yesterday afternoon.

The plaintiff is Mrs. Lizzie A. Weber,

both of Summit County.

Plaintiff prays for a decree upon the

grounds of cruelty, and upon the al-

mitted adultery at various times dur-

ing the past few months. Cruel and

unfeeling treatment has been charged,

and the plaintiff alleges that in March,

1891, the defendant struck her in the

face and knocked her down. Mrs.

Weber then states that this has been a

months by reason of the alleged treat-

nience. It is also alleged that the de-

adding her life burdens, and "making

an unnecessary and burdensome bur-

den upon the defendant" for his wife.

now resides in a rooming house, which

she occupies at Park City, and that

she has no other means of support.
