HE CARRIED THE JOKE TOO FAR.

Young Joseph Drysdale "Holds Up" His Friend—An Old Man Victimized.

DONEHEAU FOUND GUILTY.

Divorce Proceedings—A Speedy Verdict—Married—Irrigation Congress Notes—Briefs and Personals.

A complaint was sworn to last evening before Judge Howell by Henry Sewell of Wilson Lane, against Joseph Drysdale of this city charging him with robbery alleged to have been committed on the night of September 5, 1903. A warrant for his arrest was placed in the hands of Sheriff Bailey, and Drysdale was placed under arrest today.

Drysdale is about 19 years of age and is well known in this city where his parents live. The circumstances surrounding the case and very peculiar. The defendant and defendant are both employed at the Adams Canning factory. On the night of the 5th of this month Sewell went to a dance and was returning home after having taken a play a joke on him and hold him up. Accordingly Drysdale took a pistol and laid down in the sage brush along the road, when Sewell came along in his buggy, Drysdale jumped up in front of the horse and ordered him to stop and hold up his hands and get out of the buggy. Sewell complied and Drysdale ordered him to turn his back on him, and he held the pistol against Sewell's back and went through his pockets securing \$1.25. He then made Sewell get in the buggy and drive on. On his arrival home he told his parents of his experience, but had not recognized Drysdale, who returned to the factory and told the other employees, who the next day joked Sewell about being held up, and later when Drysdale saw Sewell he told him he was the holdup and gave him back the money. Sewell's father was very much enraged over the occurrence and did not take it as a joke and the complaint issued. The matter will be thoroughly investigated in the courts and may prove a very serious joke for Drysdale after it is ended.

DONEHEAU GUILTY.

In the district court before Judge Rapp, the case of the state of Utah against John Doneheau, charged with assault with intent to commit murder was completed yesterday afternoon and the jury after being out several hours brought in a verdict of assault with intent to do bodily harm, and stated that they did not see that the defendant had any provocation to shoot at John Lamoreaux, simply because they had quarreled.

THEY TRIED TO ROB HOM.

The case of the state vs William Connors and James Desmond, charged with assault with intent to commit robbery was called, but on motion of Attorney Ches, they were given a separate trial. Connors' case coming up first. The evidence of the prosecution was that the two men induced an old man named Henry Kelley to go with them to a room

over a Twenty-fifth street saloon, and then struck him over the head with a gun and tried to rob him, but he screamed and the men ran down stairs, but were caught at the bottom of the stairs by Capt. Brown and Officer Chambers and arrested. The defense is that the old man induced them to go to the room and then he tried to criminally assault them, and that in the scuffle with him, he was hit over the head with the pistol. The case was submitted to the jury this morning, and the case against Desmond was taken up.

COULDN'T RAISE THE THOUSAND.

James Sullivan charged with attempted robbery, waived his preliminary examination before Judge Howell and was bound over to answer to the district court under \$1,000 bond, which he was unable to furnish and was turned over to the custody of the sheriff.

INCOMPATIBLY MATED.

An action for divorce was filed in the Second district court by Sophia West, through Atty. T. D. Johnson, against Edwin C. West. The complaint alleges that the plaintiff and defendant were married at Ogden City April 8, 1899. That since the said marriage the defendant has treated the plaintiff in an inhuman manner, that on several occasions defendant has struck and kicked plaintiff, knocking her down. That there is no living of the issue of their marriage, and for the said three years of age. Plaintiff prays for the dissolution of the bonds of matrimony existing between herself and defendant be dissolved. That she be given custody of minor child and alimony.

\$600 VERDICT IN HALF AN HOUR.

In about 30 minutes yesterday afternoon Harold H. Wardleigh was made guardian ad litem of Raymond E. Wardleigh, a minor, an action was filed against the Rocky Mountain Bell Telephone company to recover damages and a judgment in favor of the plaintiff for \$600 was entered on the records of the Second district court. The plaintiff brought an action to recover damages from the defendant the R. M. B. T. company, in the sum of \$2,500 alleged to be due on account of defendant carelessly permitting a pole to fall on the minor, Raymond E. Wardleigh, doing him bodily harm, but by stipulation the defendants paid \$600 in full settlement of the action.

Pleasant, 6; Moroni, 6; Fairview, 6; Spring City, 6; Gunnison, Sterling, Fountain Green, Wales, each have the right to four delegates, and remaining precincts each two commercial clubs each two, farmers' institutes each two, cattle growers' associations each two.

MAYOR'S RESOLUTION.

SEPT. 12TH MEETING.

The business that will be transacted at this meeting cannot, of course, be determined now, but it is the intention, it is believed, that the convention will elect delegates to the National Irrigation Congress, who will appear before the United States senators upon this point and in that way get the deplorable state of affairs before the secretary of the Interior.

AN ORDINANCE.

An ordinance levying a tax and for the assessment of property on the west side of Third East street between Second South and Fourth South streets, in Sidewalk District No. 20, for the construction of a sidewalk.

Be it ordained by the City Council of Salt Lake City, Utah: That the City Council does hereby levy the tax and provide for the assessment upon the property hereinafter described, on or to the west side of Third East street between Second South and Fourth South streets, in Sidewalk District No. 20, for the construction of a sidewalk.

This tax is levied to defray the expense of constructing a sidewalk upon said portion of the street opposite the property hereinafter described, to be especially affected and benefited by said improvement, and it is hereby adjudged, determined and established, that the same will be especially benefited thereby to the full amount of the tax hereby levied, and said parcels of land are hereby assessed at an equal and uniform rate in accordance with the linear foot frontage upon said portion of the street.

And to a depth of twenty-five (25) feet back therefrom, and the tax hereby levied and to be assessed upon said parcels of land is one thousand seven hundred and forty-two and 1/2 (\$1,742.50) dollars, or one and 3/4 (\$1.75) dollars per front or linear foot, and the Treasurer is hereby authorized and empowered to assess in accordance with the provisions of this ordinance for the purposes herein mentioned, all of lots 1 and 2, block 55, plat "A," Salt Lake City survey, as the same are shown upon the official plat of said city.

Section 2. This ordinance shall take effect upon approval.
