Utah Federation of Labor Takes Up the Fight of the Coal Miners.

#### SOME VERY CRAVE STATEMENTS

According to Evidence Collected Utah Fuel Company is Alleged to be High Handed.

The Utah Federation of Labor met last night, and accepted the following report of John Thal on the gituation in the coal campac

SOME OBSERVATIONS.

From my observations and experience in the coal camps of Carbon country I can say without a particle of exaggeration that conditions for the miners are extremely bad. The law is used only in the interests of the coal company and it is also violated with impunity by the coal company and its hired minions. Union men are intimidated, frightened and maltreated at the point of rides in the hands of company guards. The right of free speech and peaceable assembly is denied, although the strikers are all iaw-abiding and peaceable. They are forbidden to talk to each other in groups or to hold any meeting on any pretext whatever, I know of several instances where men have been threatened with arrest unless they would go to work. Union men were prevented from coming into the towns by armed men. Eviction notices were in some men. Eviction notices were in some instances handed to tenants from the end of the rifle. When some one suggested to W. R. Ward, who was serving eviction notices that such service was not legal, he replied: "Damn the legality, so long as we make it stick."

I know of one instance where the company men deliberately emptied a man's coal shed of all the coal which had been delivered and paid for the day had been delivered and paid for the day before. This was done because the man had joined the union. In another case a man named Jones paid taxes to the county on some property he had leased from the company and the company compelled him to pay its taxes also be-

sides his regular rent.

Another example of the company's another example of the company's unscripulousness occurred when John Samuels, a company detective, and Sam Witcherly, also a company hireling, went down to the Italian qualter and tried to get them to arrange a parade for the day when Cuneo should arrive. This of course would be in violation of the lown proglamation proolation of the town proclamation pro-hibiting parades, and the Italians would have been arrested for disturb-ing the peace. Albert Aho of Clear Creek was ilred from his boarding-Creek was lired from his boarding-house because he joined the union.

At Clear Creek every morning the company guards together with a de-tachment of militia visit houses and walk in without ever knocking and grab the sleeping miner by the leg and ask him if he is going to work; if he

does not go he is served with an evic-tion notice. A very prominent militia officer said that he had not found one not be traced to the coal company. The sheriff is generally reputed to be on the payroll of the coal company and is owned body and soul by that company. He does just what the company directs, and if called upon by a union man for protection he tells him to go to hell, that he has no business to

The law provides that no warran shall be issued by a justice of the peace without the authorization of the courty attorney, but when the case 's against a striker this law is not con sidered. On the other hand, when striker wants a company thug arrested he must go fifty or sixty miles to Price to consult the county attorney,

and is always turned down.

In a speech at Demolii's trial the county attorney called the strikers worthless idlers and ungrateful wretch. He also referred to the strikers es. He also refer as Italian strikers.

Some statements here have been made showing how safe the mines are. We calf your attention to the disast-trous explosion at Scofield a few years ago. Under union regulation such disasters could not occur, for when re-ports are made by individual miners to the superintendent of any unsafe condition, he immediately invites his discharge, but when made by an organization they command attention.
