RETIRING CITY COUNCIL.

Adjourned Session is Held to Wind Up the Affairs of Old Administration.

District Court—Big Damage Suit—Marriage of Miss Moench—Local News Notes.

The city council met in adjourned session at 3:30 o'clock p. m. last night with all the members present except Councilmen Cullen and Williams. The mayor-elect and councilmen-elect had been invited and all were present except Messrs. Carr and Wright. The minutes of the previous meeting were read and approved. A refund on the amount paid for the use of the city hall square last winter as a skating pond.

On report of the special committee the four expenses, and the back salary due the late Capt. W. A. Brown, amounting to \$250, were appropriated in full settlement of all claims against the city.

City Recorder Anderson presented a list of warrants which had been called for in the recorder's office during the four years ending Dec. 31, 1897, a total of \$19,224. A motion to publish the list was lost and it was afterwards ordered filed.

City Attorney E. M. Allison, Jr., presented a lengthy report of the labors of the attorney's office for the year 1899, giving a detailed history of department cases pending or settled in the courts which Ogden city is interested. A long and interesting exhibit of the status of the case of Ogden city vs the Bear River Irrigation and Ogden Water Companies was read. The report was accepted and ordered filed.

Police Tax Collector Mendenhall reported 168 labor taxes paid and 94 cash poll taxes collected during the months of November and December, and submitted a list of 292 names of delinquents uncollected, with 69 names which were uncollectable. His bill, amounting to \$78.60, for services was ordered paid.

Street Foreman Jos. Sanders submitted a report showing that during the four years ending Dec. 31, 1897, a total of \$19,224. A motion to publish the list was lost and it was afterwards ordered filed.

On motion of Councilman Woolley \$50 were appropriated to the mayor's contingent fund.

There being no further business before the council the remainder of the time was spent in felicitous speech-making by members of the old and the incoming administration. Mayor Doyle was the first speaker and was followed by the mayor-elect, Matthew S. Brown, and by the president of the council, Thomas E. Browning. Speeches were also made by Councilmen E. T. Woolley and John P. Greer, Councilman-elect Joseph Parry, Councilman M. L. Jones, Councilman-elect H. J. Powers, and City Recorder E. H. Anderson.

The speeches were full of congratulations to the members of the council who were retiring for the past two years, and with wishes of success to the members who are about to enter upon their duties.

Councilman Jones took occasion to invite everybody present to see the fire department and to witness an alarm. This was after the manner of the department was fully demonstrated to the great delight of Chief Orson Riser as well as to the visiting dignitaries. The firemen, however, had a cold shower, though they were very thankful that there were no two hours of labor with fire and water at the end of the run.

On motion of Councilman Brewer the petition of the Citizens' Union, Watson, Woolley and Brewer a committee to approve the minutes, and at just ten minutes after ten o'clock p. m. on motion of Councilman M. L. Jones, the City Council of 1898-99 passed into history by adjourning sine die.
