WOULD-BE TRAIN WRECKERS.

Indictments Against Them, Bonds Fixed and Accused Taken to Jail.

The grand jury yesterday in Judge Miner's court found two indictments against each of the six accused to stand trial for their attempt to blow up the train yesterday morning. The first indictment charges them with an attempt to commit murder by blowing the train off the track. In such a way as to be dangerous to the public, or the safety of the passengers. The second indictment charges them with tampering with and destroying property belonging to the railroad company. An additional indictment was found against Denslow, in which he is charged with assault and battery upon the person of one John E. Hamilton, on the morning of July 17, 1894.

The boy, Weston, who accompanied the men in the course of attempted work, but who apparently took no hand in the business and who also was not present at the time of the explosion, was also taken into custody. He was found when arrested sitting in one of the wagons belonging to the wreckers.

The prisoners were without the necessary means with which to employ an attorney, so the court appointed an attorney to act for them.

The indictment were read to the would-be wreckers, who took no little notice of them apparently not realizing the seriousness of the offense, after which they were all released on bail, paying only what seemed "quality or not," all external less of but quality.

Lettuce and wife and Miss Evelyn said they take the next westbound train and proceed on their way to San Francisco, while Mrs. De Lure, the complainant, will remain to Ogden.
