### SUGAR PLANT ASSURED.

Best Growing Contracts Signed—

Special Correspondence.

Provo, Utah, Feb. 8.—George Austin,

agricultural superintendent, and

Heber Austin, field superintendent, of the

Utah Sugar company, met with the

best growers of Provo and the sur-

rounding country yesterday in the first

annual meeting of the sugar planters

of the company, for the purpose of

entering into contracts for the coming

year. There was a large attendance

of farmers, and contracts were entered

into for the number of acres prom-

ised by the farmers to the sugar com-

pany, and the company will visit Lake

View for the purpose of making con-

tracts. The total acreage subscribed

by farmers who will deliver to the

Provo cutting station is 1,000.

The company also addressed the meeting

giving instructions as to the cultivation

and care of beet crops, explaining the

terms of the contract, etc.

PROVO SUGAR PLANT ASSURED.

Mr. George Austin stated that there

would be no question about the build-

ing of the cutting station on the Bun-

nell farm, lumber and material for the

building would be on the ground by

April.

The following prices will be paid for

beets this year, delivered at the cut-

ting station, or on cars at Provo, in

case the company should consider it
