THE Springfield Republican goes along in the even tenor of its contemptible way. In this matter the Republican has even gone beyond the chief local anti-"Mormon" paper published in this city, whose chief aim is to antagonize, in every possible shape, "Mormonism" and its adherents. Even that journal treated the Chronicle tale as a Munchausenism. It

within the limits of decency and truth, to express their views on all subjects, "Mormonism and the Mormons" included, no matter whether the opinions be favorable or adverse; but when truth is ignored and its opposite used, those who thus treat popular themes are only worthy of contempt.
