# MINISTERS URGE THE AMENDMENT

Want a Sixteenth Article Added to the United States Constitution to Prohibit Polygamy-Draft the Article and Issue an Address.

its secretary, Mr. Balley, last evening, after the "News" had gone to press, offered this paper, a copy of an address, to the "American People" regarding alleged polygamous conditions in Utah, and asking that Congress secure the adoption of an amendment to the national Constitution in relation thereto. Accompanying the address is the amendment the Salt Lake law-making preachers would like to have adopted. Both address and amendment

THE LOGIC OF THE SITUATION IN UTAH: ARE WE READY FOR THE NEXT STEP?

The Ministerial association of Sait Lake City, Utah, including in its mem-bership representatives of all the Evangetical denominations, congratulates the ministers, newspapers, Congress. men and especially the great host of Christian women throughout our country, upon the success of their energetic and patriotic efforts to exclude the notorious polygamist, B. H. Roberts of Utah from the national House

of Representatives.

The substantial unanimity with which the House voted to exclude Mr. Roberts—268 to 59—is a most encouraging fact to the law-abiding citizens of our commonwealth. We, who daily witness the bold and shameless effrontery of polygamy in this, its modern stronghold, are well qualified to appre-ciate the beneficial effect of this prompt vindication of the American conception of home and family life. To all who helped to bring about this most happy issue, we desire to express our fervent

Nevertheless, those who are most fa-maliar with the history of the Mormon hierarchy, the small value to be put upon their public statements on this subject, and the persistent zeal with which they defend and propagate their polygamous tenets, are of the opinion that another step forward is absolutely necessary to preserve inviolate the purity of American home-life and con-serve the fruits of the victory already Nothing short of a tutional amendment providing for the disfranchisement and total political disability of all who practice polygamy effective in stamping out this relic of

We urge the adoption of such a constitutional amendment for the follow-

Nothing short of this will uproot the evil of which we complain. The doctrine of polygamy is so inwrought the the Mormon system that only the ost strenuous measures will avail to revent the practice thereof. In proof of this statement we give the following extracts from approved works and speeches of high officials in the Mor-

'For, behold! I reveal unto you a new and an everlasting covenant (plural marriage); and if ye abide not that covenant, then are ye damned."—Doc.

On May 2, 1885, prominent Mormons from all parts of Utah assembled at Salt Lake City for the purpose of drafting a "Declaration of Grievances and Protest" against the persecution of polygamists under the Edmunds law. polygamists under the Edmunds law. We give an extract from a document prepared by the convention and submitted by the then Delegate from Utah, John T. Caine, to President Cleveland: "Among the principles of our religion is that of immediate revelation from God; one of the doctrines so revealed is celestial or piural marriage, for which

ostensibly we are stigmatized and hated. This is a vital part of our religion, the decisions of courts to the contrary notwithstanding."
On June 13, 1898, Apostle Wilford Woodruff spoke to the young people's conference at Castle Dale, Utah. Tak-

Woodruff spoke to the young people's conference at Castle Dale, Utah. Taking up the subject of polygamy, he "stated that the belief in polygamy was as much a part of the faith of the Mormon Church today as it ever was.

It was impressed upon the minds of the young people that they could not deny this part of the Mormon belief without at the same time denying the Prophet Joseph Smith, on whose advice it was first practiced."—Salt Lake Herald, June 15, 1898.

In a public address at Logan, Utah, November 15, 1898. Apostle Heber J. Grant said he "felt to sustain the principles of the Gospel even to the extent of taking more wives if necessary."—Logan Nation, a "Mormon" newspaper.

The lengthy defense and labored arguments made in support of polygamy by B. H. Roberts in the May, 1892, number of the Improvement Era are too well known to need quoting here. Even monogamist "Mormons" believe Even monogamist "Mormons" believe in the rightfulness of polygamy, though they do not practice it; witness the reply of Gov. Wells to some strictures of Mr. Roberts in the fall of 1898, where he said: "I would rather my tongue were torn from its roots than that I should utter a word against the divinity of the section of polygamy which gave me system of polygamy which gave me

Second-The evasive course and measures pursued by the "Mormon" hier-archy since Statebood was secured for Utah, clearly show that no reliance can be placed upon their most solemn pledges to the federal government in relation to the cessation of the practice of polygamy or polygamous cohabita-

It is well known that Statehood was granted to Utah on the specific condition that the practice of polygamy and polygamous cohabitation should en-tirely cease. In the sworn testimony of the President and leaders of the Church, before the master in chancery, in order to recover the escheated property of the Church, they plighted their sacred honor that polygamous rela-tions already contracted should abso-lutely cease. Have 'they kept their promises? Let the facts speak, Lo-renzo Snow, now President of the "Mormon" Church, has had nine wives.
Among those still living is his legal
wife, Sarah Snaw (see Utah Reports,
Vol. IV., n. 282, Case of the United States vs Snow), yet he is cohabiting

Those cases are but specimens of multitudes of others which could easily be cited did space but permit. They are sufficient, however, to show that the leaders of the Church have shamelessly broken faith with the govern-ment of the United States. It is not, therefore, strange that with such conspicuous examples constantly their eyes, the lesser lights are not slow to follow sult. There is hardly a com-munity in the State but what has had

its coterie of polygamous Saints.
Remembering the selemn pledges of the leaders as to the cessation of polygamy and polygamous practices, the ratification of those pledges by two successive conferences of the "Mor-mon" people, we stand aghast in face of the active and persistent violation of those pledges today.

Third-Our State laws are so framed as to make it exceedingly difficult, and in some cases impossible, to secure con-viction for the crime of polygamy or polygamous cohabitation, for the rea-son that in most of the counties the machinery of the law is largely in the hands of the Priesthood or subject to their control. In most instances, even If conviction be secured, the penalty is either minimized or evaded in such manner as to encourage rather than restrain lawbreakers.

Utah law makes no provision for a grand jury, but clothes the county atorney with sole and exclusive power to determine when prosecutions in cases of polygamous cohabitation shall be entered upon. If his personal sympathies are with the offender, or if prosecution is locally unpopular, this official, under one pretense or another, may avide the programmes of his may evade the performance of his sworn duty.

When in October last complaint was made that President Snow was living in polygamous relations with one or more plural wives, the county attor-ney of Salt Lake county refused to entertain the complaint because of alleged difficulty in proving that the President had any legal wife now liv-ing, and that in face of the decision of the Supreme court cited above.
The county attorney of Davis coun-

ty has, by a series of evasions, proved his utter unwillingness to undertake the duty of prosecution, although since October 14, 1899, he has had in his possession sworn information charging that Mr. B. H. Roberts is living in polygamous relations with Celia Dib-

In the cases of Angus M. Cannon, president of Salt Lake Stake, and Apostle Heber J. Grant, a plea of guilty was entered, and they received a minimum fine of \$100 without imprisonment, though the statute provides for a fine of \$300 and six months' im-prisonment. The fine inflicted in these flagrant instances was no punishment for men of their abundant means, even if they had personally paid the whole amount, but when, as in the case of President A. M. Cannon, the sum was contributed by co-religionists, the whole transaction was little better than farcial.

That the offense of polygamous co-habitation is not rare is proven by the fact that in one small county (Cache) complaints have recently been filed against thirty-one offenders, nearly all of them prominent in Church circles and members of the Priesthood. We urge, therefore, most earnestly, that this whole matter of dealing with

polygumy and polygumous conabita-tion be placed under the direct juris-diction of the federal courts. Fourth-The intention of the Mormon leaders that disfranchisement would inflict unnecessary hardship, is

entirely misleading, inasmuch as only defiant and continued transgression of the law would incur the penalty. Furthermore, experience has demon-strated that no legislation has been se effective in restraining the evil of polygamous cohabitation as the pro-vision in the Edmunds-Tucker law dis-

franchising those who persisted in its Fifth-The pretense made by its advocates that polygamy will soon die out if left alone, cannot be true, because the system tends to perpetuate itself and out of the 1,543 acknowledged cases many are still in the prime of Those high in authority, also, do cease to encourage the people to hope for the removal of the restraints put

upon polygamous practice by manmade laws. There is not the slightest indication that polykamy and the bindred offenses are dying out in this State. On the contrary we deliberately affirm that the practice of polygamous cohabitation has been more open and defiant during the last two years than at any period since 1889. It is not true that all those who practice polygamous cohabitation are old and decrepit. J. M. Tanner, Moses Thatcher, Joseph Silver, Or-son F. Whitney, Samuel G. Thurman, Prof. Hickman, B. H. Roberts and Apostles Cowley and Grant are men who are still in the prime of life, and there are scores of such pelygamists in Utah. Moreover, we have "crying evidence" that many of the oldest polygamous men have young plural wives. There are literally hundreds of polygamous wives in Utah who have not passed their prime, and these women have quite as much to do with keeping the evil alive as the men.

Sixth-Not only in Utah is the preservation of the American home involved in the settlement of this question. In several contiguous States the Mormons have already secured the balance of political power, and their rapid growth presages absolute control in the near

This proposed amendment to the Federal Constitution is needed in Idaho, Nevada, Montana, Wyoming and Colo-rado almost as much as in Utah. Many of our Utahan polygamists are becoming citizens of these States, and many others maintain polygamous interstate relations. This latter class makes light of State laws. Some of these adright of State laws. Some of these ad-loining States, as Idaho, are almost as popular as Mexico with our lawbreakers as a place of refuge. There seems to be no adequate legislation against polygamy and polygamous cohabitation in some of these States. The polyg-amists of southern Idaho "live their religion" without let or hindrance, and claim their share of county, State and Pederal offices. Were we of Utah able to enforce our State laws we could scat-ter our polygamic plague, but the ad-joining States would be the worse for it. Nothing save Federal action will

extirpate this national shame.

Seventh—As further evidence of the need of such a constitutional amend-ment, we cite the action of the Mormon leaders, as shown in their vigorous op-position to the proposed measure. The Deseret News declared that Utah would be one of the first States to Indorse such a constitutional amendment prohibiting polygamy, yet, in spite of this, Apostle John Henry Smith, Bishop Clawson, both active polygamists, and other in-fluential leaders of the Church have for weeks been using their utmost en-

deavors to prevent the proposal of such an amendment. Their greatest fear at this moment is that Congress will take steps to submit an amendment of this nature to the Federal Constitution to he several States for their approval. We copy the following verbatim from the issue of the Deseret News of October 18, 1898. The News, let it be remembered, is the official organ of the Mormon Church: "From what has been said on the subject, it is sufficiently clear that if Congress takes the matter up in the form of an amendment to the Federal Constitution, Utah will be among the first States to ratify such an among the first States to ratify such an

For the above reasons, and others which might be urged with equal force, we plead for the speedy adoption of a constitutional amendment such as is suggested in the accompanying form: PROPOSED ANTI-POLYGAMY CON-

STITUTIONAL AMENDMENT.

(Article XVL) Section 1. Neither polygamy nor polygameus cohabitation shall exist within the United States, or any place

subject to their jurisdiction Sec. 2. Polygamy or polygamous cohabitation, whether practiced within the bounds of a State or a Territory of the United States, shall be treated as a crime against the peace and dignity of this Republic,

No person shall be Senator or Representative in Congress or elector or President or Vice President, or hold any other office of henor or emolument. whether civil or military, under the United States, or under any State or Territory thereof, or be permitted to yote at any election for any of said officers in either State or Territory, who shall be found guilty of polygamy or polygamous cohabitation, but Congress may, by a vote of two-thirds of each house, remove such disability in any

Sec. 4. The Congress shall have power to enforce the provisions of this ar-ticle by appropriate legislation.
