Interestate Commerce Hearing Will be Held in City Of Pueblo.

BIG DISCRIMINATION IN RATES.

Colorado Fuel & Iron Company Pays Just Half What Small Dealers Do.

Pueblo, Colo., Dec. 3 .-- United States Commerce Commissioner E. E. Clark, assisted by Atiys. Thomas and Marchand, this morning began an investiration of "alleged land frauds and the relations between common carriers to the production of coal and oil and the mansportation of same."

This was the way the commisioner explained his visit to Pueblo. It is understood that a large number of witpesses will be examined today in conrection with the coal land holdings of the Colorado Fuel and Iron company, the Denver & Rio Grande, the Colorado the Denver & Rio Grande, the Colorado & Southern and Santa Fe realizonds for the purpose of securing data which Will be submitted to Congress for definite action. Should the investigation bring out facts to warrant it, however, the matter will be brought to the attention of a special United States grand jury. tailed for the purpose of indicting those against whom charges may be

Lincolu, Neb., Dec. 3.—William J. Bryan made an address at the opening of the union labor fair tonight, in which he said in part "There is a great gulf existing be-tween the tolling classes and those who live without tolling, but at the presnt time brain and muscle are working in closer harmony that they have for many years. Today the world does not care for the non-producer, and the lacare for the non-producer, and the la-borer ranks much higher than the idle man who lives on the income left him. "The dignity of labor has been so pro-claimed over the land and impressed on the minds of the people that it will not be long until the world will point the finger of disgrace at the man who lives in idleness. The moral question also is involved in this. A man who refuses to work cannot attain a high moral standard. The real pauper is not the man living in poverty, but the one that

man living in poverty, but the one that does not produce anything. The pauper may be found among the rich classes, where idleness takes the place of work.
